REPORTS BY CITY MANAGER

City Manager Ray E. Corpuz Jr. reminded the Council that Council Members Baarsma and Miller, Mayor Ebersole, and environmental staff person Judith Lorbeir have been intimately involved with the Chinook salmon issue. He stated that the Tri-County Executive Committee submitted a package to the media which contained actions that this Council adopted February 16 — a commitment to early action to deal with the issue of endangered salmon. He then stated that the National Marine Fisheries Service made a commitment towards the City of Tacoma to address this issue. Mr. Corpuz then reported that Matthew Schwartz, Executive Director of the Thea Foss Waterway Public Development Authority, is resigning to return to Miami Beach. He stated that Mr. Swartz came to us with the credentials of an experienced professional in the development area, particularly the public side of the development arena, so we will miss that expertise. He said we are losing a valuable resource who has contributed a great deal in the short time he has been here.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Baarsma moved to excuse Council Member Miller and Mayor Ebersole from tonight's meeting. Seconded by Council Member Silas. Voice vote was taken and carried. The motion was declared adopted.

Council Member Silas thanked those who attended from the Hilltop Action Coalition, then wished everyone a happy St. Patrick's Day.

Council Member McGavick mentioned "Women's Awareness Week" and "Women's Awareness Month." She noted there had been a Girl Scout luncheon last week with many staff attending. She congratulated the winners, in particular Babe Ware, who has been very active in community events.

Council Member Baarsma discussed an article in the March issue of the Los Angeles Times regarding light rail.

Council Member Crowley congratulated the Dome staff for the good job they did in putting on the boys' basketball tournament. He congratulated Bellarmine, Wilson and Lincoln for a good job even though they did not win.

On proper motion, the meeting was adjourned at 7:20 p.m.
