Council Member Kirby expressed appreciation to City Manager, Ray E. Corpuz, Jr., for the information he received about the City Council's budget. He requested more details such as a ledger or list with a description of each account.

Council Member Kirby added that 19 years ago today Mrs. Kirby made it official and consented to be his wife.

Council Member McGavick congratulated all the parents in the audience for encouraging their children to read. She indicated that reading was a basic skill that they will have with them for the rest of their lives. She then encouraged the students to continue reading.

Mayor Moss stated that he and L. C. Johnson, Assistant Superintendent of Region II, Elementary Schools, visited several elementary schools today. He stated that he thoroughly enjoyed what he saw - the students had manners and the schools were clean and cheerful. He indicated that he would be returning to spend more time with the students to talk with them, to learn their concerns, and where they are going.

Deputy Mayor Miller moved to excuse Council Member Crowley from tonight's meeting. Seconded by Council Member Silas. Voice vote was taken and carried. The motion was declared adopted.
