### Resolution No. 35252

Authorizing the Tacoma Police Department to submit an application to the Office of National Drug Control Policy, Counterdrug Technology Assessment Center, Technology Transfer Program, for a transfer of technology products to the Special Investigation Division of the Tacoma Police Department.

Deputy Mayor Phelps moved that the Resolution be adopted. Seconded by Council Member McGavick. Voice vote was taken and carried. The Resolution was declared adopted.

### Resolution No. 35253

Modifying the Six-Year Comprehensive Transportation Program to allocate necessary funding to the "East 48<sup>th</sup> Street - McKinley Avenue to Portland Avenue" project to provide and allow submission for available funding grants and reduce the local funding allocated to the "East 64<sup>th</sup> Street - Pacific Avenue to Portland Avenue" project to a partial level.

Deputy Mayor Phelps moved that the Resolution be adopted. Seconded by Council Member Moss. Voice vote was taken and carried. The Resolution was declared adopted.

#### Resolution No. 35254

Authorizing the execution of an Ash Disposal Agreement with Pierce County Recycling, Composting, Disposal LLC, in the amount of \$550,000, for disposal of non-recycled ash from the City's Steam Plant.

#### Resolution No. 35255

Authorizing the execution of an agreement with the William M. Factory Small Business Incubator, in the amount of \$122,238, to administer the Eastside Small Business Incubator Program in accordance with the 2001-2002 Tacoma-Lakewood Consolidated Plan for Housing and Community Development.

Deputy Mayor Phelps moved that the Resolution be adopted. Seconded by Council Member Miller. Voice vote was taken and carried. The Resolution was declared adopted.

#### Resolution No. 35256

Authorizing the execution of an agreement with the Associated Ministries of Tacoma-Pierce County, in the amount of \$54,592, for the Paint Tacoma-Pierce Beautiful Project, in accordance with the 2001-2002 Tacoma-Lakewood Consolidated Plan for Housing and Community Development.

Mayor Crowley congratulated City Manager Ray E. Corpuz, Jr. for the award he received from the International City Manager's Association for his implementation of Total Quality Management, the Moneyback Guaranty program through the Building and Land Use Services Division, and other programs.

Council Member Davis mentioned that the Eastside Neighborhood Council meets every third Monday. She stated that the next meeting will be held Monday, August 20, 2001, at 6:30 p.m., at the Portland Avenue Community Center; and she encouraged people to get involved.

Deputy Mayor Phelps congratulated Mayor Crowley for restarting the Mayor's Cup Golf Tournament. He stated that the tournament, which was held at North Shore Golf Course, raised \$10,000 for the YWCA. He thanked staff and the volunteer committee for their efforts.

Council Member Evans stated that first annual Tacoma International Music Festival will be held this week at the Pantages and Rialto theaters. He invited citizens to attend and stated that the schedule is listed in *The News Tribune*.

Council Member Scarbrough announced that the South Tacoma Business District Association is having its fifth annual Classic Car Show and Community Festival this Saturday, August 18, from 10 a.m. to 4 p.m. She stated that the activities would take place beginning at South 54<sup>th</sup> and South Tacoma Way with activities for adults and children.

Council Member Moss announced that there would be a Town Hall Meeting for District 3 on Tuesday, August 21, from 6 p.m. to 8 p.m., immediately following the City Council meeting. She stated that both the City Council meeting and the Town Hall meeting would be held at the Evergreen State College, 1201 Sixth Avenue, in "The Commons" Room.

Mayor Crowley recognized Council Members Moss and Dahl for their birthdays on August 20. He stated that the Deputy Mayor's wife, Linda, is celebrating a birthday today.

Mayor Crowley invited everyone to the celebration for the beginning of the construction of Team Tacoma's project on the Thea Foss Waterway. He stated that the celebration will be held on Tuesday, August 21, 2001 beginning at 10 a.m.

Mayor Crowley noted that he had received a phone call from former Council Member Jack Warnick, who reported that a restaurant within a residential area of our Sister City Kiryat Motzkin, Israel, had suffered a bomb attack. Mayor Crowley stated that he would send a letter to the Mayor of Kiryat Motzkin, expressing condolences regarding the tragedy.
