REPORTS BY CITY MANAGER:

Mr. Ray E. Corpuz, Jr., City Manager, announced that the Police Department is accepting applications for the 22nd Citizen's Academy, a 13-week program starting on February 21, 1996.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Council Member Baarsma moved to excuse Council Member Kirby from the Council meeting of January 16, 1996. Seconded by Council Member De Forrest. Voice vote was taken and carried. The motion was declared adopted.

Mayor Ebersole thanked Allen Correll, Human Rights Department, for the wonderful job he did at the Martin Luther King, Jr. Celebration. Mayor Ebersole indicated that approximately 5,000 people attended the celebration, which made it one of the largest celebrations in the nation.

Council Member Baarsma congratulated Council Member Evans on his tenure as Deputy Mayor and highlighted some of his accomplishments. Council Member Baarsma stated that as Deputy Mayor he led the fight on behalf of the citizens of Tacoma to convince the Federal Department of Energy not to import nuclear waste through our Port. He also met with the Port Commission to lead the City Council in negotiations on the 11th Street Corridor, which resulted in the 11th Street Bridge not being closed until I-509 is complete. Deputy Mayor Evans was also instrumental in establishing a port relationship with Hachinohe, Japan. Council Member Baarsma also expressed his appreciation to Allen Correll, Human Rights Department, for the Martin Luther King, Jr. Celebration.

Deputy Mayor Silas expressed her appreciation to Council Member Evans as an outstanding job as Deputy Mayor. She also thanked staff for a great job on the Martin Luther King, Jr. Celebration. Deputy Mayor Silas complemented Mayor Ebersole on his speech at the Martin Luther King, Jr. Celebration. She also expressed concern over the Human service projects.

Council Member McGavick thanked Larry Dahl, outgoing chair of the Urban Policy Committee, for all of his hard work and congratulated him on his newly elected position with the Park District. She also expressed concern over the difficult decision-making process regarding the Human service projects. Council Member McGavick congratulated Deputy Mayor Silas on her first meeting as Deputy Mayor.

Council Member Miller expressed concern over the timelines of the Human service projects and stated that he would like to see the process completed by November or December to allow the agencies better certainty on funding. He also stated that he would like to see the City Council and the Urban Policy Committee meet sometime in the middle of the process to discuss the projects.

Council Member Evans thanked his Council supporters. Council Member Evans commended everyone involved with the production of the Martin Luther King, Jr. Celebration.



Council Member De Forrest stated he was unable to attend the Martin Luther King, Jr. Celebration because of work. Council Member De Forrest suggested discussing sidewalks at the workshop scheduled for February 2 and/or February 3.

Mayor Ebersole thanked Council Member Evans for his service and dedication to the City of Tacoma as Deputy Mayor.

On proper motion, the meeting was adjourned at 8:47 p.m.
