The poll indicated overwhelmingly that the members wished to have the vacancies for unexpired terms filled by an election. This Ordinance would set up the mechanism to accomplish that.

Ordinance No. 20931

Amending Chapters 4.02, 13.04, and 13.06 and repealing and reenacting Chapter 13.10 which set forth Shoreline segment designations, use regulations, and permit procedures to implement the goals and policies of the Master Program for Shoreline Development.

Peter Rasmussen of the Planning Commission advised that the position of the Planning Commission is that the Ordinance, in its present form, does not alter the recommendations of the Planning Commission.

Mike Smith, Planning Department, advised that the proposed seven amendments are incorporated in the Ordinance.

Speaking to the Ordinance were:

Nancy Thomas, member of the Shoreline Master Program Citizens' Advisory Committee, who took exception to changes numbered 3, 4 and 5, which are on page 108 of the Ordinance.

Hugh Barden, lessee of certain City property along the Shoreline, took exception to change number 7, which appears on page 13.

Armand Labbe, Manager of ASARCO, requested further amendments as follows:

Section 13.10.090(1), on line 7, page 49, after word "including" and before the word "commercial" the words "pre-existing industrial" be inserted.

On page 53, line 16 and 17, the words "land fill related to the expansion of a pre-existing use pursuant to draft ordinance Section 13.10.190 3. Providing that it is accomplished in accordance with Sections 13.10.035.11.A - 13.10.035.11.8 General Regulations." City Council Minutes - Page 10 - December 7, 1976

Gary Kucinski, representing the Port of Tacoma, advised that the Port supports change number 7.

Nancy Kroening, a member of the Shoreline Master Program Citizens Advisory Committee, objected to changes number 5 and 7.

Carolyn Simonson, representing a group of citizens called "Save Our Shoreline", objected to change number 5 on page 108.

Walton McGee, member of a group who own undeveloped property along Ruston Way, felt that their needs should be considered as to the value of their property if they are not going to be able to develop it.

Robert Ellner, a resident near Ruston Way, spoke in favor of ASARCO's use of their land.

Chuck Keenan, representing WETA (Western Environmental Trade Association), submitted a prepared statement to Council members and summarized. He raised questions and sought answers from Council and Mr. Barker, Assistant City Attorney.

E. K. Murray, attorney, representing certain property owners along the shorelines, spoke.
