City Manager Ray E. Corpuz, Jr. invited members of the Council, the public, and employees to participate in celebrating Black History Month on Thursday, February 22, 1996, from noon to 3:00 p.m., in the seventh floor conference room. He also stated that there will be a Town Hall meeting on Thursday, February 22, 1996, at 7:00 p.m., at the Manitou Community Center, 4806 S. 66th Street.

### **COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:**

Council Member Miller moved to excuse Deputy Mayor Silas from the Council meeting. Seconded by Council Member Crowley. Voice vote was taken and carried. The motion was declared adopted.

Council Member Baarsma commented on the achievement of Olympic athlete Leo Randolf.

Council Member Kirby indicated that he had received a letter from the South Tacoma Neighborhood Council regarding a reclassification for Peoples Furniture on Tacoma Mall Boulevard and requested that staff respond to the concerns. He also expressed dissatisfaction with the format of the Town Hall meetings as they had evolved and expressed his preference for the format of the meetings.

Council Member McGavick also commented on the Town Hall meeting format.

Council Member De Forrest also commented on the Town Hall meeting format. He announced that the Eastside Neighborhood Council's quarterly meeting will be held on Thursday, March 21, 1996, at Sheridan Elementary School. He then stated that they have three board positions open. Council Member De Forrest requested staff to clarify the reason funds donated to the D.A.R.E. program takes 13 to 15 months to get into the program. Council Member De Forrest then reported that the Superintendent of Public Instruction has a report out that measures the success or lack of success of 9,000 students throughout the state involved in the D.A.R.E. program and requested to see the results of the Tacoma School District. He then asked staff for clarification on sidewalk repair letters so that he can respond to citizens.

Council Member Kirby requested the City Manager bring forth a Resolution declaring a moratorium on initiating new notices for hazardous sidewalk repairs or replacement.

Council Member Evans requested clarification on what the process is now for sidewalk repair.



Mayor Ebersole reported that he had the pleasure of representing the City of Tacoma at the Vietnamese New Year's celebration in the 38th Street International District near Lincoln High School. He stated that the celebration was very impressive and he enjoyed it very much.
