REPORTS BY CITY MANAGER

City Manager Ray E. Corpuz, Jr. reported that the Pierce County Prosecutor's Office and the City of Tacoma has a new partnership with the use of a new Computer Forensic Laboratory. He stated that the computer will be used to solve crimes and provide additional evidence. He stated that training to use the computer will be provided through the Pierce County Prosecutor's Office. Mr. Corpuz stated that prior to the Computer Forensic Laboratory in the Prosecutor's Office, the only other laboratory was with the State of Washington.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Deputy Mayor Baarsma stated that he and Council Member Evans had the opportunity to participate in a 20-member Washington State Delegation who attended the Cascadia Forum, which was held in Vancouver on Thursday, Friday and Saturday. He stated that the Cascadia Forum was made up of representatives from the Greater Vancouver Regional District, Portland Metro, and the Puget Sound Regional Council. He then stated that the focus of the discussion and theme was transportation and issues of regional concern.



Deputy Mayor Baarsma stated that he and Council Members Evans also had the opportunity, as members of the Library Task Force, to pay a brief visit to the Vancouver Library. He stated that the full Library Task Force should also visit that facility. He stated that after listening to some of the issues that deal with urban design and regional concerns, his appreciation for Council Member Evans being on the City Council was greatly enhanced because of his visionary qualities.

Council Member Evans stated that a trip to Vancouver is always instructive. He stated that one of the speakers, James Howard Kunstler, has written several books on how to build a city or region. He then discussed some of Mr. Kunstler's books.

Council Member Evans stated that he also toured West Broadway Street in Vancouver. He stated that West Broadway Street has the same type of development that the City of Tacoma has in the Proctor District or on South 38th Street. He then described the development.

Mayor Ebersole stated that he had the opportunity to go to the Harvard School of Design in Boston and learned how elected officials are designers and responsible for the physical look of our cities. He stated that he would be talking to Council Members and the Foss Public Development Authority to give them the benefit of what he had learned from the architects, developers and urban planners who had been at the conference.

Council Member Kirby stated that last Friday night he attended the annual Police Awards Banquet which was well attended and very informative. He stated that the highlight of the evening was that Council Member Dave De Forrest received the Councilman of the Year Award. He then expressed his congratulations to him.
