L. Frank Johnson, Attorney for Mr. Ristvet, reviewed the reasons why the appellant and other objectors in the neighborhood felt the rezone should not be allowed. He answered questions of Council members.

Bob Backstein reviewed the rezone request and all the procedures that had been followed for the hearing and answered questions for Council.

After discussion, Mr. Nelson moved that the appeal be denied. Seconded by Mr. Nielsen. Voice vote was taken and carried, with Mr. Strege dissenting.

PUBLIC HEARINGS:

This is the date set for hearing on the Business & Occupational Tax rates levied on travel agencies. (Larry Clark, President, Travel Center, Inc.)

Larry Clark, President, Travel Center, Inc., advised that the State Legislature recently reduced the B & O tax on travel agencies as they felt recent interpretations of State law taxed the travel agencies an unfair amount. Mr. Clark asked that the Tacoma City Council follow the State and reduce the B & O tax on travel agencies.

It was the feeling of Council members that tax adjustments should not be made on a piece meal basis. Comment was made on the fact the City has a Citizens Municipal Tax Advisory Committee which was established a year ago to review all B & O taxes and make recommendations to Council. Mr. Warnick asked Erling Mork, the City Manager, to write to Dr. Robert Waldo, Chairman of the Committee, to find out the statue of their review.

Mr. Hudson moved to continue the travel agencies' appeal until such time as Council takes action on the B & O tax recommendations of Dr. Waldo's Committee. Seconded by Mr. Nelson. Voice vote was taken and carried.

COMMENTS BY MEMBERS OF THE CITY COUNCIL:

Mr. Hudson asked that staff supply Council with information on "Progress House". He also commented he felt it advisable that Dr. Waldo's Committee report to Council within 30 days.

Mr. Hudson asked for a study session on the Hearings Examiner process sometime within the next six months for the purpose of considering possible amendments.

Mr. Sonntag asked that his recent request for an ordinance relating to taxes on non-profit organizations holding one raffle or bazaar each year be scheduled for a study session as soon as possible.

Nr. Strege listed the following suggested reforms to aid in legislative functions and asked for advice on them from other Council members: Advance delivery date of the agenda by one day in order to allow time for research on agenda items; the feasibility of additional equipment for the Council's research room; invite public comment during study sessions; suggested Friday as a better day for study sessions; suggested use of non-salaried University interns who could assist the Council members with research; allow public hearings on major policy issues; reform the budget review process in order to allow Council members earlier participation in the budget review. Inquiry was made by Deputy Mayor Warnick as to possible problems in advancing the delivery date of the agenda. Erling Mork advised he would research the matter and report back.

Deputy Mayor Warnick suggested the subject of the budget review process be discussed at a study session to determine procedures.
