## FIRST READING OF ORDINANCES:

Ordinance No. 24379

Amending Section 1.12.230 of the Pay and Compensation Plan and creating a new Section 1.12.232 providing for the coordination of sick leave benefits for LEOFF I Employees.

The Ordinance was set over for final reading next week.

Ordinance No. 24380

Authorizing funding for seating improvements in the amount of \$172,000.00; transferring \$72,000.00 from the Contingency Fund to the Tacoma Dome Operating Fund; declaring bench seating of the estimated value of \$40,000.00 removed from the Tacoma Dome to be surplus property; and utilizing \$60,000.00 previously appropriated for seating improvements for the purpose of improving restroom facilities at the Tacoma Dome, and appropriating \$112,000.00 from the Tacoma Dome Operating Fund, and declaring an emergency making necessary the passage of this ordinance.

Mayor Sutherland moved to amend Ordinance No. 24380 on page 1, line 3, to delete the words "seating improvements" and insert the words "improving restroom facilities." Seconded by Council Member Vialle. Voice vote was taken and carried. The motion was declared adopted.

Mayor Sutherland stated that it would be his intention to move to amend the Ordinance to improve only the Lower A restroom facility at next week's meeting.

The Ordinance, as amended, was set over for final reading next week.

Ordinance No. 24381

Authorizing the execution of an agreement for the Fifteenth Year Community Development Block Grant Program with the U.S. Department of Housing and Urban Development in the amount of \$2,513,000.00; depositing in and appropriating said sum from the Community Development Grants Summary Fund for carrying out certain Community Development programs.

The Ordinance was set over for final reading next week.
