Amending Chapter 13.06 of the Official Code to change the classification of the east side of Pacific Avenue between Division Lane extended and South 36th Street extended from an "R-3" and "C-1" to an "R-5-TM" District. (Puget Sound Hospital)

### FIRST READING OF ORDINANCES:

Ordinance No. 20891 Providing for the levy of ad valorem taxes for the fiscal year 1977.

Earl Mittlestaedt, Finance Director, explained the City's method of taxation and estimated revenues.

The Ordinance was set over for final reading next week.

Ordinance No. 20892 Amending Chapter 5.26 of the Official Code relating to the keeping of dogs and other animals.

Archie Fiddler, Director of the Tacoma/Pierce County Humane Society, reviewed the present procedures, complaints, and the problems the Humane Society is having in enforcing the "leash law", and answered questions of Council members.

Marie Cave, citizen, spoke in favor of the Ordinance and suggested a \$15 fine be imposed for the first offense in place of the \$5.00.

Citizens also speaking were: John Yonker, Raymond Roland and Marion Grace.

After considerable discussion, Mr. Nielsen moved to amend the ordinance on page one, ine 25, to change the sum of \$5.00 to \$10.00 for the first offense; on line 26, the sum of \$15.00 be changed to \$20.00 for the second offense; and on page two, line two, the sum of \$25.00 be changed to \$35.00 for the third offense. Seconded by Mr. Sonntag.

After further discussion, Mr. Warnick requested that figures on the repeat pffenses of the last year be presented to Council by next week.

Mr. Warnick moved to continue to next week vote on the motion to amend the ordinance. Seconded by Mr. Nielsen. Voice vote was taken and carried,

The Ordinance was set over for final reading next week.

Ordinance No. 20893 Authorizing the execution of an agreement with the University of Puget Sound to accept \$2,400.00 for a Work Study Program in the Human Relations Department and authorizing the necessary transfer and appropriation of funds to carry out the program.

Resolution No. 24111 Authorizing the City to transfer Tide Air, Inc. fixed base operator lease to Air Gemini, Inc. and authorizing an amendment to the agreement.

Mr. Nelson moved that the Resolution be adopted. Seconded by Mr. Nielsen.

Resolution No. 24112 Authorizing the execution of a security and maintenance agreement for Tacoma Industrial Airport with Air Gemini, Inc.

Mr. Hudson commented he is interested in addressing the subject of Health care in a working session with the County in a study session type atmosphere.
