Resolution No. 24367

Authorizing application to the State of Washington for the sum of \$165,000.00 in Referendum 29 funds for the purpose of constructing a group care facility for developmentally disabled persons.

Speaking on the Resolution were Arthur Brown, representing El Comite, who asked that the facility have a staff member with bilingual abilities.

Elmer Church, Chairman of the Board of the Developmentally Disabled Persons, Answered questions of Council members regarding his program.

Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 24368 (First Reading)

Amending Rules 9 and 11 of the Rules of Procedure of the Council of the City of Tacoma.

Mr. Sonntag moved that the Resolution be adopted. Seconded by Mr. Strege.

After discussion, Mr. Strege moved to delete lines 15, 16 and 17. Seconded by Mr. Sonntag. Voice vote was taken and carried.

After further discussion, Mayor Johnston moved to continue second reading of the Resolution for ten weeks. Seconded by Mrs. Bichsel. Voice vote was taken and carried. Second reading of the Resolution was continued to June 7, 1977.

Mayor Johnston moved to suspend the rules in order to consider Resolution 24369. Seconded by Mr. Nielsen. Voice vote was taken and carried.

Resolution No.24369

Creating an Energy Task Force.

The Clerk read the Resolution in its entirety. Mayor Johnston moved that the Resolution be adopted. Seconded by Mr. Warnick.

Mayor Johnston submitted the following names to be inserted into the Resolution: Ted Cross, Chairman of the Utility Board; Jack Creighton, designee of the City Manager; Aldo Benedetti, Director of Utilities; Armand Labbbe of ASARCO, Douglas LaPenski of Frisbies Bakery; Paul Meyer, 6322 North 26th, a senior citizen; and Mrs. Lorraine Ebert, 1015 South 64th Street, a citizen at large.

Mayor Johnston announced that there will be a public meeting on Monday, April 4, 1977 at the Public Utilities Auditorium at 7:30 p.m. and another public meeting on energy conservation on Thursday, April 7, 1977 at 7:30 p.m. at a place yet to be determined.

Voice vote was taken on the Resolution and carried. The Resolution was declared adopted.

APPEALS:

This is the date set for hearing Stanley V. Dunning's appeal on the Hearings Examiner's decision to approve the site plan for a "CPC" Planned Community Shopping Center District at the Northwest corner of South 76th and Pacific Avenue.

Following a detailed presentation by Mr. Dunning, Mr. Sonntag made a motion to deny his appeal. Seconded by Mr. Strege. Voice vote was taken and carried.

Mayor Johnston moved to suspend the rules to hear some brief comments from Mrs. Lillian Babbitt, President of the Metropolitan Park Board. Seconded by Mr. Nelson. Voice vote was taken and carried.

Mrs. Babbitt urged better communications between the Council and the Park Board and suggestion a joint meeting once every two months to accomplish this end. She also suggested that a member of the Council attend the regular Park Board meetings if at all possible.

COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Mayor Johnston appointed the following Council members to the L.I.D. Committee for April, May and June, 1977: Deputy Mayor Warnick, Mr. Hudson and Mayor Johnston.

Mr. Schroeder expressed concern and asked the City Manager to contact the Tacoma-Pierce County Humane Society with respect to dogs running at large. He related how a woman was knocked down by a large dog and seriously hurt while walking in her neighborhood.

Mayor Johnston made a motion to recess into Execution Session to discuss a property matter. Seconded by Mr. Schroeder. Voice vote was taken and carried. The Council recessed at 7:45 p.m.

The Council reconvened at 8:20 p.m., whereupon Mr. Sonntag moved that the City Manager be and he is hereby authorized and directed to retain an independent real estate appraiser for the purpose of preparing certain appraisals of property which the City may hereafter sell or acquire. Seconded by Mr. Nielsen. Voice vote was taken and carried.
