Mayor Sutherland introduced Mr. John Palmiter of the Pierce County Veteran's Advisory Council. Mr. Palmiter introduced members of the Veteran's Council and the Exchange Club who were instrumental in getting the Freedom Shrine exhibit in the Tacoma Dome.

Providing for the formation of L.I.D. No. 3904 for the construction of sanitary sewers in an easement approximately 120 feet west of and parallel to McKinley Avenue from East 88th Street north 500 feet, more or less.

Mayor Sutherland moved to remove Ordinance No. 24094 the the agenda. Seconded by Council Member Moss. Voice vote was taken and carried. The motion was declared adopted.

Ordinance No. 24094 was removed from the agenda.

Ordinance No. 24095

Transferring \$100,000.00 from the Capital Improvement Program Fund, \$60,000.00 from the Stadium and Convention Center Trust Fund, and \$190,000.00 from the Contingency Fund; depositing in and appropriating \$350,000.00 from the Tacoma Dome Operating Fund to clean and recoat the Tacoma Dome roof.

Mayor Sutherland moved to suspend the rules to consider Substitute Ordinance No. 24095. Seconded by Council Member Nielsen. Voice vote was taken and carried. The motion was declared adopted.

The Substitute Ordinance was set over for final reading next week.

Ordinance No. 24096

Appropriating \$75,000.00 from the Capital Projects Waterway Fund to transfer the ownership of the steam plant property on City Waterway from the Department of Public Utilities to General Government; and declaring an emergency making necessary the passage of this ordinance.

The Ordinance was set over for final reading next week.

Ordinance No. 24097

Authorizing the sale and issuance of the City's Sewer Revenue Bonds, 1988 in the aggregate principal amount of \$37,500,000.00 to provide part of the funds necessary to redeem and retire outstanding sewer revenue bond anticipation notes of the City.

The Ordinance was set over for final reading next week.

Mayor Sutherland moved that the Council consider Public Hearings and Appeals. Seconded by Council Member Warnick. Voice vote was taken and carried. The motion was declared adopted.

PUBLIC HEARINGS AND APPEALS: (Began at 5:37 p.m.)

a. This is the date set for hearing the appeal of Jack L. and Mary-anne Callinsky, of the request of A. G. Masters for the reclassification of the property located on the northwest corner of South 19th and Visscher Streets (6001 South 19th Street) to allow the development of a professional law office. Mayor Sutherland reviewed the procedures for appeals before the City Council.

Mayor Sutherland stated that he has known Mr. Callinsky for a number of years, but this friendship will have no bearing on his decision on this matter.

Rod Kerslake, Hearings Examiner, made a presentation to the Council regarding his decision.

Mr. Jack Callinsky gave the reasons for his appeal.

Mr. Dennis McBreen, 1802 South Visscher, spoke against the Hearing Examiner's decision.

Mr. Arlie G. Masters, Attorney, spoke in support of the Hearings Examiner's decision.

Mr. Joel Masters, 4248 Sunset Beach, also spoke in support of the Hearings Examiner's decision.

Council Member Stenger moved to uphold the Findings, Conclusions, and Decision of the Hearings Examiner and deny the appeal. Seconded by Council Member Moss.

Discussion followed regarding the proposed motion followed.

Deputy Mayor Hyde stated that he worked at Tacoma Community College and that this would not have any bearing on his decision on the appeal.

Roll call vote was taken on the motion, resulting as follows:

Ayes: 3 - Moss, Nielsen, and Stenger.

Nays: 6 - Hyde, McElliott, Mykland, Vialle, Warnick, and Mayor Sutherland.

The motion was declared failed.

Council Member Vialle moved to overrule the Hearings Examiner and uphold the appeal. Seconded by Council Member Mykland.

Roll call vote was taken on the motion, resulting as follows:

Ayes: 7 - Hyde, McElliott, Moss, Mykland, Vialle, Warnick,

and Mayor Sutherland.

Nays: 2 - Nielsen and Stenger.

The motion was declared adopted.

The appeal was upheld.
