## REPORTS BY CITY MANAGER

City Manager Ray E. Corpuz Jr. reminded everyone that City offices will be closed on Wednesday, November 11, 1998, in honor of Veterans Day and will re-open for business again on Thursday, November 12, 1998.

## COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member McGavick thanked the City Manager for the parking lot sign which states that citizens can park for free to attend City Council meetings and study sessions.

Council Member Miller stated that the City of Tacoma was highlighted nationally on the television program Jeopardy last night.

Council Member Baarsma complimented Council Member Miller for the fine job he did in representing the City of Tacoma last Sunday in Seattle. He stated that they were visiting Dale Chihuly's shop and greeting the delegation from Taos Pueblo, New Mexico, who are developing a relationship with the Hilltop Artists in Residence program at Jason Lee Middle School. He stated that it was a great opportunity to watch the glass blowing process at work.

Council Member Baarsma then stated that many people were surprised last Tuesday night, on election night, when Jim Janos pulled off one of the great upsets when he was elected governor.



Mayor Ebersole stated that he was unable to attend the study session because he was in Seattle at the Cascadia Mayor's Conference. He stated that the mayors from British Columbia, Washington State, Oregon State, Vancouver B.C., and Victoria B.C. were in attendance. He stated that they discussed regional issues such as drug trafficking on I-5 and how the respective police departments might work together. He stated that they also discussed regional transportation and the pursuit of bringing the Olympics to Puget Sound in the year 2012. Mayor Ebersole stated that Mayor Schell, of Seattle, is frustrated that the Seattle City Council will not vote to explore the possibility. He stated that it takes a Resolution by a City Council in the area to get the Olympic Committee to formally examine the feasibility of the Olympics coming to the area. He stated that it was suggested that the Tacoma City Council send a Resolution to the Olympic Committee requesting them to consider the Puget Sound Region as the Olympic site in the year 2012. He then asked the City Attorney to prepare a Resolution.
