Council Member Miller moved to postpone the vote of revising line 17 of Ordinance No. 24827 by striking "\$400.00" and replacing it with "\$100.00" for one week. Seconded by Council Member Mykland. Voice vote was taken and carried, with Deputy Mayor Stenger voting nay. The motion was declared adopted.

#### Ordinance No. 24828

Authorizing the issuance of \$19,250,000.00 of Refuse Utility Revenue Bonds to finance capital improvements for the Refuse Utility System.

Authorizing the execution of a sewerage rate agreement with Pierce County for sewerage services provided by the City and Pierce County.

Council Member Mykland moved that the Resolution be adopted. Seconded by Council Member Nielsen. Voice vote was taken and carried. Deputy Mayor Stenger abstained from voting. Deputy Mayor Stenger stated he would abstain from voting on this item since he worked with Pierce County Utility as part of his job with the Pierce County Prosecutor. Resolution No. 31209

Authorizing the release of three sewer easements near East 15th and St. Paul Avenues to clear encumbrances on the property.

Council Member Mykland moved that the Resolution be adopted. Seconded by Council Member Nielsen. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 31210

Authorizing the execution of an amendment to the retainer agreement with Preston Thorgrimson to increase the aggregate total of the contract to \$150,000.00 for the case of Roberson v. City of Tacoma.

Council Member Mykland moved that the Resolution be adopted. Seconded by Council Member Miller. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 31211

Authorizing the execution of a License Agreement with Tacoma Hockey Enterprises, Inc., for the use of the Tacoma Dome facilities for five years for Western Hockey League games beginning with the 1991-1992 season.
