Amending Chapters 13.06 and 13.06A of the Municipal Code relating to drive-through uses along the downtown light rail corridor and other minor changes for the downtown area and the area surrounding the Tacoma Dome.

### Ordinance No. 26606

Authorizing the execution of a grant agreement with the Interagency Committee for Outdoor Recreation, in the amount of \$750,000; accepting, depositing in and appropriating said sum from the Thea Foss Waterway Development Authority Enterprise Fund for the construction of 30 slips of transient moorage at the Albers Mill site on the Thea Foss Waterway.
