## REPORTS BY THE CITY MANAGER

City Manager Ray E. Corpuz, Jr. reported on a communication from the Washington State Department of Community Trade and Economic Development. The report indicated that the State Office of Archaeology and Historic Preservation is presenting the State Historic Preservation Officer Award for outstanding achievement in historic preservation. He stated that Tacoma was selected to receive a 1996 State Historic Preservation Award for outstanding achievement in preservation planning for the Hilltop neighborhood and thanked Deputy Mayor Silas for her encouragement and support. Mr. Corpuz gave a "hats off" to the staff and the Historic Preservation Officer Valerie Sivinski. Mr. Corpuz also reminded the Council that Friday, May 10, 1996, is the Law Enforcement Officers' Memorial Service Ceremony in honor of officers who have died in the line of duty. He stated that the ceremony will be held in the courtyard at the Tacoma Convention Center at noon and encouraged all to show their support for our officers.

## COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Deputy Mayor Silas reported on the Torchbearer Ceremony. She stated that it was a very emotional and proud event. She further stated that it was a time the City came together, forgot all problems, and was just happy in the joy of seeing the people who were selected to carry the torch, realizing that all members were representative of the different cultures and that we were all one as Americans.

Council Member Crowley also commented on the Torchbearer Ceremony and commended Mayor Ebersole and the organizers for a job well done.

Council Member McGavick also commented on the Torchbearer Ceremony, how it was an exciting time, a once in a life time event, and a great uplifter as one of the Public Utility workers carried the first torch. She also reminded citizens that a Town Hall meeting will be held at Truman Middle School on Thursday, May 9, 1996, at 7:00 p.m. She encouraged all to come out to meet and greet the City Officials and to have their questions answered.

Council Member Baarsma reported that last weekend he had the honor and privilege of standing in for the Mayor at the Workers' Memorial Ceremony along Ruston Parkway to read our Resolution on behalf of all those employees who have died as a result of a work-related accident or disease. He stated that it was a very emotional event because his father happens to be one that would be a part of this memorial. Council Member Baarsma requested that the City Manager Ray Corpuz keep him apprised of the progress made on identifying a memorial site.

Council Member Evans stated that last Saturday there was a meeting regarding the Chinese Reconciliation Project. He stated that the project is moving forward, that the persons who are involved in that effort invited the Council to a presentation of the plan as it is now proposed, and that money is diligently being raised. Council Member Evans further stated that the project will be a major asset to the City because it will recognize the Chinese community in particular, and it will become a kind of focus for gatherings along the waterfront where there will be a Chinese garden and a Chinese pavilion as well as the history of the project.

Mayor Ebersole commented on the Torchbearer Ceremony, stating that he was honored to have taken part in the Olympic torch relay. He stated that the flame that began in Athens, Greece, and that will end up in Atlanta, Georgia, passed down the streets of Tacoma on a blustery afternoon. Mayor Ebersole further commented that it was quite a proud moment for the Tacomans that were there, that the ceremony of the torch coming into the City and leaving the City was quite a sight to see, and that he was glad to be a part of that historic event. He also stated that it was significant that the Torch was not carried by professional athletes in our community, but by average, local heroes, some of which contributed significantly to volunteer services for many, many years without recognition. He reported that the Torchbearer Ceremony will be aired on TV Tacoma.
