COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Council Member Baarsma reported that he had joined with Council Member De Forrest, Acting Police Chief Ken Monner, and Lieutenant Dave Brame in a very productive and positive meeting with a group of Safe Streets organizers to discuss the concept of personally-assigned patrol vehicles.

Council Member Evans mentioned an editorial from the *The News Tribune* about the need for a trauma care in Pierce County. Council Member Evans stated that the City of Tacoma, the Pierce County Executive, members of the Medical Society and various hospital groups are in the very early stages of putting together a plan to address the trauma care issues in Pierce County.

Council Member Miller requested information from the Finance Director Peter Luttropp regarding 1995 home occupancy licenses. Specifically, Council Member Miller wanted to know how many were first-time occupancy permits rather than repeat home occupancy permits, how many actual inspections City departments had done in 1995 on the locations of home occupancy permits, and what compliance actions were taken in 1995 on home occupancy permits. Council Member Miller requested a follow-up memo clarifying the options for funding of the Pierce County Drug Court.

Mayor Ebersole announced that he has reappointed George R. Harvey, Jr., as a Commissioner for the Tacoma Housing Authority effective January 2, 1996, through January 2, 2001.
