City Council Chambers January 28, 1992

The meeting was called to order by Mayor Vialle at 5:03 p.m.

Edward and Margaret Hudson, appealing the decision of the Hearings Examiner relative to the reclassification of the property north of South 13th Street between South Pine and South Junett Streets from a "R-2" One-Family Dwelling District to a "C-2" Commercial District to allow the construction of an expansion to the existing Peerless Laundry building. Mayor Vialle announced that the Municipal Services Center dedication of the old TCI Building will be held at 11:00 a.m. on January 30, 1992 at 1224 South "K" Street. The public is invited to attend.

Mayor Vialle announced that the Sister City Flags normally behind the dias are currently at the Tacoma Dome for the Home and Garden Show.

Mayor Vialle stated that this week our community lost one of our greatest volunteers, Helen Sater, the founder of "Citizens Against Crime. She stated that Helen's spirit of volunteerism will remain in everyone's heart.

Deputy Mayor Mykland commented that guns that have been collected through illegal use are kept in a joint storage facility used by the Tacoma Police Department and the Sheriff's Department.

Council Member Evans asked if the concerns discussed at a joint county/city meeting would have any effect on the laws regarding the resale or the auction of those weapons.

Mayor Vialle stated that the weapons will be inventoried and then disposition of those weapons will depend on the outcome of the legislative session.
