### REPORTS BY CITY MANAGER:

City Manager Ray E. Corpuz, Jr. reported on the election results of the Community Council. He stated that Marion Weed was elected president, Maurice Wright was elected vice president, Barbara Grout was elected secretary, and Leah Shier was elected treasurer. He then thanked Mr. Skip Vaughn for the last two years of service as the president of the Community Council. Mr. Corpuz then reported that Len Simon will be in Tacoma on Monday, February 12, and encouraged Council Members to schedule some time to meet with him. He stated that Mr. Simon will be available on both Tuesday and Wednesday, February 13 and 14. Mr. Corpuz then reported that the election results will run on a continuous crawl on TV Tacoma starting at 8:30 p.m. and will be updated until 10:30 p.m. He then announced that Public Assembly Facilities Director John Croley had been nominated for the 1995 Concert Industry Awards

Facility Executive of the Year. He then congratulated the Tacoma Dome staff for an excellent 1995.

### COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Council Member Kirby requested that Mozzella Pooley's concerns be responded to. He also requested that the issue of posting signs on telephone poles be re-addressed.

Council Member Miller requested information on the reclassification of property on South 19th Street southwest of Mildred. He requested information on the cost to the City for 135,000 gallons of water and which department is responsible for paying for that cost.

Council Member Crowley commented on the workshops held on Friday, February 2 and Saturday, February 3 at the Landmark Convention Center, and complimented the City Manager and staff, especially Dwight Faust, for facilitating the meeting.

Council Member Baarsma reported that a provision of Section 4.15 of the Charter empowers the Council to initiate a general management survey of the Utilities. He stated that he would be meeting with the management consultants and would be willing to convey any particular concerns to them that anyone might have. Council Member Baarsma stated that he intends to focus on two issues which are the integration of our strategic planning efforts of Public Utilities and General Government and secondly, further implementation of Section 4.17 or Proposition No. 3 which hopefully will lead to exploring where we can consolidate staff services and continue to save money. He then stated that the City Manager reported savings of 1.2 million dollars for the biennium through the efforts made to date on Proposition No. 3. Council Member Baarsma then commented on an article appearing in the Sunday News Tribune Business Section entitled "Power Plays," which described the issues we will be facing through deregulation. He stated that this will be one of the biggest issues that we have before us of important significance and reported that the article discussed profound changes in the Utility industry in the next five years.

Council Member De Forrest reported that he was also in receipt of phone calls and letters on the proposed reclassification that went before the Planning Commission. He stated that, it is his understanding, this property is owned by the Public Utilities Department and that they are requesting a reclassification to surplus the property. Council Member De Forrest then encouraged citizens to vote today. He next voiced his concern about a brochure received in the mail from People for Parks that listed the Tacoma City Council as endorsing the Metropolitan Park bond levy. He stated that the City of Tacoma did not endorse nor oppose the Metropolitan Park bond levy. Council Member De Forrest reported that the Eastside Improvement Club and the Puyallup Tribe met regarding the proposed casino. He reported that the Puyallup Tribe brought real estate agents in to see if anyone wanted to sell their home because of their need

for land for 1,400 vehicles to park their cars, a gas station, a restaurant, and the casino. Council Member De Forrest then wanted to know if the settlement agreement with the Puyallup Tribe stated that the City of Tacoma should be informed of these types of activities.

Mayor Ebersole again expressed his condolences to the friends and family of Jim Salatino.
