 That the improvement will ensure compliance with all appropriate health and safety laws, rules and regulations;

2. That said installation will insure that rental value increases will, over a stated period of time, liquidate the subsidy of the General Fund."

Seconded by Councilman Hawkins. Voice vote was taken and carried.

Roll call vote was taken on the amended Ordinance, resulting as follows:
