#### COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Council Member De Forrest indicated that two weeks ago Council Member Baarsma had requested information on analyzing the proposal from the Small Business Incubator on the T Street Gulch cleanup project. He also indicated that he had requested staff to locate a funding source for the cleanup project. Council Member

De Forrest instructed staff to prepare a resolution for next Tuesday's Council meeting that would allow the Incubator to help with the T Street Gulch cleanup project.

Council Member De Forrest noted that several weeks ago Council had requested information on the card room tax. Mayor Moss replied that the Council was provided information on the card room tax in the Friday Letter packet. Mayor Moss indicated that he has requested that the City Manager have a resolution prepared on a card room tax proposal for Council's consideration.

Council Member De Forrest emphasized that if the agenda materials indicate that the backup materials are on file in the City Clerk's Office, then the materials should be on file there.

Council Member Kirby expressed concern about the time of hour when the Citizens' Forum portion of the Council agenda is heard. He requested that a resolution be prepared for the Council's consideration changing the time when Citizens' Forum are to be held to 7:00 p.m. Council Member Kirby indicated he was flexible about the time designated for citizens to speak.

Council Member McGavick also agreed with Council Member Kirby.

Council Member Crowley expressed his apologies for not being able to attend the Town Hall meeting on Thursday, September 15 and next week's Council meeting when the Summer Library Reading awards will be held.

Council Member Baarsma announced that today President Clinton signed the crime bill into law. Council Member Baarsma stated that he sent thank you letters to Representatives Dicks and Kreidler and Senator Murray. Council Member Baarsma reported that he received a letter from Mr. Len Simon listing some of the key dates that will be affected by the passage of this legislation. Council Member Baarsma stated that on October 1, Attorney General Reno and her staff will be reviewing the applications of those cities not receiving funding for the community-orienting policing program. The City of Tacoma's application will be considered during this review. Council Member Baarsma noted that Tacoma's application requests matching funds for five additional police officers. Also, in October 1995, the crime bill's Local Partnership Act will go into effect and Mr. Len Simon will be notifying the City of what this will mean for the City of Tacoma. He has indicated that it could mean Tacoma would receive between \$2-\$3 million in assistance. Council Member Baarsma also noted that in October 1995 the crime prevention block grants will go into effect which will allow the City to continue a number of programs.

Council Member Silas thanked the Public Works Landfill Division for a very informative and enjoyable afternoon.

Council Member Evans reported that two weeks ago the Council adopted a resolution to include Paine field into the discussions of a major supplemental airport. Council Member Evans indicated at the last hearing he attended at the Convention Center in Seattle, there were 250 people from Snohomish, North King County, etc. and five people from Pierce County. He explained that the northern counties have established a strong campaign against any location for an airport, emphasizing they would like to keep it rural. Council Member Evans indicated that the The News Tribune made no mention of this Council's action on passing a resolution two weeks ago; however, The News Tribune did note the King County's resolution. Council Member Evans indicated that the Puget Sound Regional Council will meet next week to vote on three sites which were the product of the discussions that took place at the Convention Center. He explained that the three sites include two of which are in Snohomish County -Marysville east and Arlington. The third site is Lake Tanwax in Pierce County. The fourth site is the McChord air field which was put in a different category to be considered for future uses as a supplemental airport. Council Member Evans read a letter he received from Representative Kreidler, requesting not to adopt two recommendations that the Growth Management and Transportation Policy Boards approved at the Convention - 1) excluding Paine Field as a possible site for a supplemental airport; and 2) requesting that the Washington State congressional delegation seek a study with the Department of Defense and the FAA on the feasibility of using McChord Airforce Base as a civilian airport.

Deputy Mayor Miller noted that it is important to establish a time when Citizens' Forum will be held so that the public has advanced notice of when Citizens' Forum will be heard. Deputy Mayor Miller suggested that the Forum be held at 6:00 p.m. to coincide with the time set for public hearings. Deputy Mayor Miller urged everyone to vote in the primary election on September 20. He also urged everyone with an opinion on the Medic One levy to vote.
