CONSENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Council Member Bichsel reminded Council Members Stenger and Kirby that there is an Appointments Committee meeting on Monday, August 20, 1984 at 6:00 p.m.

Council Member Ladenburg stated that through the Association of Washington Cities he has been appointed by the Supreme Court to the Judicial Evaluation Review Commission in the State of Washington. He said that over the next two years this commission will review the entire judicial system, including the Municipal Courts and how they operate in conjunction with the District Courts. He said if anyone on the Council has any suggestions he could take to the commission about the court system - how it operates and how it might be changed to benefit cities or otherwise - please give him that information during the next few months.

Council Member Kirby said he has been getting complaints from citizens about vacant lots being overgrown with berry bushes and just overgrown in general. He asked the City Manager's Office to check with other cities to see what their policies are on situations of this type.

Council Member Kirby said that a citizen approached him about the parking around our building and being in the building longer than the parking limit specifies and their being given a ticket for over-parking. He suggested that signs be put up at the entrances of this building stating that there is a parking lot available and parking tickets will be validated by offices within the building.

Council Member Kirby moved to excuse Council Members Rasmussen and Hyde from last week's meeting and to excuse Council Member Hyde from this week's meeting. Seconded by Council Member Bichsel. Voice vote was taken and carried.

Council Member Warnick said the barricade at North 37th and Stevens has been the site of two accidents and he would like to know if there isn't some way to improve that corner to make it less hazardous. He also stated that as you walk on the sidewalk around that area you have to walk around berry bushes and he would like to see if those could be cut back to the fence.

Mayor Sutherland said the K Street Boosters are sponsoring a concert in People's Park on August 19, 1984, and were most anxious to put this program together. As a result of discussions with City staff the Boosters were aware that the City does help sponsor these kinds of activities throughout the City. However, they got a little ahead of themselves in how they handled the situation and Mayor Sutherland asked the Civic Arts Commission and the Finance Department to review what the Boosters have done financially to see if the City can participate in the sponsorship of this program as we have in other concerts throughout the city.
