# COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Mayor Moss moved to excuse Council Member Silas from the remainder of the City Council meeting. Seconded by Deputy Mayor Miller. Voice vote was taken and carried. The motion was declared adopted.

Mayor Moss announced that the Council meeting of May 31, 1994 was canceled and that the next regularly scheduled meeting of the City Council would be held on June 7, 1994, at 5:00 p.m. in the City Council Chambers.

Mayor Moss announced that the City of Destiny award presentations would be held on Tuesday, June 14, 1994, at 6:00 p.m., in the City Council Chambers.

Mayor Moss stated that the Council shared in Council Member Baarsma's recent loss and wished him well.

Deputy Mayor Miller made comments and a report on his recent trip to Germany that he took with the City Manager and the Public Works Director. He stated they had received reports from 14 different countries and many locales on their efforts on redevelopment of industrial sites. He reported on the use of public development authorities.

Deputy Mayor Miller stated there would be a reception this Thursday evening at the Union Station honoring Mayor Moss. He stated the public was invited to attend.

Council Member Evans stated he had received a communication from Dr. Brad Patterson, regarding the Tacoma Narrows Airport Parcel B lease. He requested that this be printed for all Council Members and that it be examined.

Council Member Baarsma stated that the fireworks issue posed some issues. He stated that two years ago there was a commitment on the part of the City to work with community service organizations to explore innovative ways to assist them in their fundraising efforts. He requested some follow through on the part of the City on this matter. He related the discussions that the Mayor and Council Members had had with the citizens in possibly being more innovative in celebrating the Fourth of July at the neighborhood level. He requested that the City Manager put a group together to find ways to do this.

Council Member Kirby stated that he had received publicity and credit for the proposal before the Council on the Three Strikes Domestic Violence Ordinance. He stated that he had handed this assignment to staff and expressed his thanks and appreciation to the staff involved in this, in particular, Chris Bacha, Cheryl Carlson, the City Manager, Pat Bosmans, and Heidi Horst. He also gave thanks to Kyle Crews of the City Attorney's Office.

Council Member De Forrest noted that there was not a City Council meeting next week; however, he stated there was a study session on May 31, 1994, at 5:00 p.m., in the sixth-floor conference room, in the Municipal Building.

Council Member De Forrest then reported on his trip to Charleston, South Carolina for the Community-Oriented Policing Conference. He stated it was a good program and many good ideas were shared. He spoke regarding some of the activities in the area and indicated that Charleston, South Carolina had had a recent crime incident and within a 24-hour period the Mayor announced a commitment to hire 10 more officers to assist in law enforcement efforts. Council Member De Forrest stated that in the next budget session he would be requesting 55 more police officers to be hired by the City.

Mayor Moss expressed his gratitude to the Council and staff for their patience and understanding during these long Council meetings and their dealing with the difficult issues before the Council.
