

MINUTES OF THE TACOMA CITY COUNCIL BUDGET HEARING

City Council Chambers
November 16, 1987

Deputy Mayor Rasmussen called the public hearing to order at 5:05 p.m.

Council Members present: 4 - Mykland, Stenger, Warnick and Deputy Mayor Rasmussen. Absent: 5 - Hyde, McElliott, Moss, Nielsen and Mayor Sutherland. Council Members McElliott, Moss and Nielsen arrived at 5:07 p.m.

Deputy Mayor Rasmussen announced that the purpose of the public hearing was to review the 1988 Preliminary Budgets for the Tacoma-Pierce County Humane Society, Tacoma Public Library, Law Enforcement Support Agency, the Tacoma-Pierce County Health Department and the Tacoma Metropolitan Park District.

Deputy Mayor Rasmussen announced that copies of the 1988 Preliminary Budget for the Tacoma Public Library were available to the public at the back of the Council Chambers.

Deputy Mayor Rasmussen announced that this was a regular, advertised public hearing and that notice was duly published and should be incorporated by reference into the record.

At 5:07 p.m., Ms. Jeanne Werner, Director of the Tacoma-Pierce County Humane Society, presented the department's budget for 1988.
