Ordinance <u>No. 24399</u>

Amending Chapter 13.06 of the Official Code to reclassify the property located on the west side of East "D" Street between East 32nd Street and East Wright Avenue from an "R-4-L" Low Density Multiple-Family Dwelling District to an "R-4-T" Residential Commercial Transitional District to construct a 44,600 square foot office building on the site. (Hansen, Hansen, and Johnson; File No. 120.1265)

Council Member McElliott stated that due to discussion and participation in this matter and on the matter regarding Ordinance No. 24400, she would be abstaining on Ordinance Nos. 24399 and 24400.

Council Member McElliott then left the Council Chambers.

Vacating East 32nd Street from East "D" Street between the freeway and East "D" Street to combine the abutting properties to provide a site for a proposed office building. (Ralph H. Kerr; File No. 124.882)

Mayor Sutherland moved to concur in the Findings, Conclusions and Recommendations of the Hearing Examiner. Seconded by Council Member Mykland. Voice vote was taken and carried, with Council Member McElliott abstaining. The motion was declared adopted.

Authorizing entry of a consent decree with the U.S. District Court consenting to remedial action at the Tacoma Landfill Superfund site; appropriating \$511,158.26 from the Refuse Operating Fund to pay the U.S. Environmental Protection Agency; appropriating \$83,610.65 from the Refuse Operating Fund to pay the Washington State Department of Ecology for investigation and oversight costs.

Council Member Mykland moved that the Substitute Resolution be adopted. Seconded by Council Member Vialle. Voice vote was taken and carried. The Substitute Resolution was declared adopted.

Resolution No. 30524

Authorizing the execution of an agreement in the amount of \$29,000.00 with Reed/Reinvald for architectural and engineering consultant services for the renovation of the Point Defiance Senior Center.

Council Member Mykland moved that the Resolution be adopted. Seconded by Council Member Vialle. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 30525

Establishing the official City Policy on Place Names and Name Changes.

Council Member Nielsen moved that the Resolution be adopted. Seconded by Council Member Moss.

Council Member Stenger moved to delete the word "deceased" on page 2 of the draft policy under paragraph 3 of the "criteria." Seconded by Council Member Vialle. Voice vote was taken and carried. The motion was declared adopted.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Council Member Mykland stated that last Friday he went on a ride-along with the Tacoma Police Department. He complimented Greg Hopkins, the officer he rode with, and recommended that all Council Members participate in a Police Department ride-along.

Council Member Nielsen moved to excuse Deputy Mayor Hyde from the meeting of July 25, 1989. Seconded by Council Member Vialle. Voice vote was taken and carried. The motion was declared adopted.

Mayor Sutherland stated that there was a public hearing set on tonight's agenda for August 29th regarding the exemptions from view sensitive overlay zoning districts. He stated that one of the items that was in the original ordinance was not in the substitute ordinance that was passed by Council some time back. He stated that this public hearing will begin to correct that oversight. Mayor Sutherland then called upon George Hoivik of the Planning Department.

George Hoivik, Planning Department Director, stated that there were six single-family houses that exceeded the height of the view ordinance. He discussed the process and stated that there would need to be an amendment to the view moratorium in order to accommodate these particular family residences.

Council Member Vialle asked if all of these houses were in the Harborview Ridge Plat.

George Hoivik stated that he would check this out and report back to the Council.

Mayor Sutherland stated he was asking the Planning Department to bring an ordinance to begin to amend the view moratorium for discussion next week.

Council Member Moss moved to reconsider Purchase Resolution No. 30522. Seconded by Council Member Warnick. Voice vote was taken and carried. The motion was declared adopted.

Purchase Resolution No. 30522 (Purchase Item No. 6) was reconsidered.

Raul O'Baya, owner of Semia Construction spoke to the Council regarding Purchase Item No. 6. He protested the award of Purchase Item No. 6 to Robison Construction, Inc.

Mayor Sutherland called on Mike Smith of the Legal Department for comment on this matter. Mike Smith, Assistant City Attorney, spoke regarding the problem regarding Semia's bid.

Bob Sparling, Public Works Department, responded to inquiries regarding meetings held prior to the bid. Discussion followed regarding bid bonds, performance bonds and sureties.

Discussion then centered around the waiving of the bid defect on Purchase Item No. 6.

Raul O'Baya provided comments regarding the waiver of bid defect and made statements regarding his bid.

Council Member Mykland moved to reaffirm the Council's decision on Purchase Item No. 6. Seconded by Council Member Nielsen. Voice vote was taken and carried, with Council Member Moss voting nay. The motion was declared adopted.

Mayor Sutherland moved that employees of the City of Tacoma be authorized to wear such comfortable clothing as they deem appropriate and in good taste during the month of August 1989. Seconded by Council Member Mykland. Voice vote was taken and carried. The motion was declared adopted.

Council Member Vialle stated that there would be a meeting this week of the Retirement Board at which an early retirement proposal window of opportunity would be presented. She requested that the Council be kept informed of this concept and proposal.

Mayor Sutherland stated that this would be coming back before the Council for future discussion, if presented to the Retirement Board.

On proper motion, the meeting was adjourned at 7:05 p.m.
