He stated that ASARCO representatives gave an update which has generated the need for an additional follow-up meeting in January after the ASARCO auction. He concluded by stating they held the second out of a series of four discussions on the Neighborhood Business Districts to give a historical background, where they are, where they are headed, and the potential for the creation of new business districts to allow individuals to make improvements to their areas.
