The meeting was called to order at 5:04 p.m.

Present on roll call: 7 - Bichsel, Nelson, Nielsen, Schroeder, Strege, Warnick, and Mayor Johnston. Absent: 2 - Hudson and Sonntag.

Mayor Johnston made a motion to excuse Councilman Hudson because he was testifying at a legislative hearing in Olympia. Seconded by Mr. Nielsen. Voice vote was taken and carried. Councilman Hudson was excused from the meeting.

Mayor Johnston then made a motion to suspend the rules for the purpose of hearing a report from Mr. Peter DeMark, Executive Director of the Tacoma Housing Authority. Seconded by Mr. Schroeder. Voice vote was taken and carried.

Mr. DeMark then approached the Council to present the Council with a check for \$65,898.16. He stated the check was from the Tacoma Housing Authority for payment in lieu of taxes for the period January 1 through December 31, 1976. He also presented the Council a current copy of the Tacoma Housing Authority's Annual Report.

Mr. Schroeder made a motion to suspend the rules for the purpose of considering Resolution No. 24384, which declares the City's interest in acquiring the Roxy Theater as a performing arts theater for the benefit of the Citizens of the City. Seconded by Mr. Warnick. Voice vote was taken and carried.

Speaking in support of the Resolution was Mrs. Virginia Shackelford, President of the Pantages Theater Restoration Project and a member of the Tacoma/Pierce County Civic Arts Commission and Mrs. Ellida Kirk, President of the Arts Advisory Council of Pierce County and also a member of the Tacoma/Pierce County Civic Arts Commission.
