Mayor Baarsma asked for a friendly amendment on page 3, line 4, for the positions to be Chair and Vice-Chair instead of Chair and Co-Chair.

Council Member Anderson moved that the amendment be adopted. Seconded by Council Member Phelps. Voice vote was taken and carried. The amendment was declared adopted.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Phelps moved to excuse Deputy Mayor Ladenburg and Council Member Evans from the meeting. Seconded by Council Member Talbert. Voice vote was taken and carried. The motion was declared adopted.

Council Member Lonergan recognized several City employees, including Mr. Tom Margeson, Building Maintenance, General Services Department, for his cost savings in repairing the seats at the Pantages Theater; Mr. Bill Bailey, Land Use Planner, Public Works Department, retiring after 31 years of service; Ms. Emelia Laurente, Customer Service, Sewer Utility, retiring after 30 years of service; and Ms. Dorothy Anderson, Graphics Division, General Services Department, celebrating her 30th anniversary with the City of Tacoma.

Council Member Talbert stated there would be another Eastside clean-up project and thanked the City Manager and staff for working with the neighborhood group to clean up the neighborhoods. He also stated he is tracking predatory loan agencies that prey on the most vulnerable citizens, and stated that he is aware that the City Manager has asked staff to start looking at model language for potential legislative solutions.

Council Member Phelps stated the City of Seattle's Broadband and Telecommunications Task Force told Seattle city leaders they needed to implement a citywide fiber-optic network. He was complimentary to Tacoma's City staff for the vision of Tacoma Public Utilities, the Public Utility Board, and the City Council, for moving forward to implement CLICK! Network several years ago.

Mayor Baarsma expressed his appreciation to the Council for the amount of time they dedicate to committees and for representing the citizens of Tacoma, and he reminded everyone the City of Destiny awards will be held tonight at Jason Lee Middle School and invited the public to attend.

On proper motion, the meeting was adjourned at 6:13 p.m.
