City Council Chambers January 13, 1998

Resolution No. 33930

Resolution No. 33937

Authorizing the submittal of a grant application to the Washington State Department of Ecology, in the amount of \$40,000, for the development and implementation of a comprehensive stormwater education program.

REPORTS BY CITY MANAGER

City Manager Ray E. Corpuz, Jr. invited everyone to attend the 10th Annual Dr. Martin Luther King, Jr., Birthday Celebration on Monday, January 19, 1998, from 11:00 a.m. to 1:00 p.m. at the Tacoma Dome Exhibition Hall. He stated that this event includes a free continental breakfast starting at 10:00 a.m., as well as free bus rides to the event and free admission. He stated that this is the largest celebration in the state of Washington and one of the largest in the nation.

Mr. Corpuz then introduced and welcomed Ms. Genal Gavaldon, Planning and Development Services Department, as the Special Assistant to the City Manager's office through the end of March.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Baarsma stated that this past weekend, the intrepid aviator Harold Bromley passed away at the age of 99 in Palm Desert, California. Council Member Baarsma stated that Harold Bromley attempted to fly non-stop across the Pacific Ocean in a plane called the "Spirit of Tacoma." Council Member Baarsma stated that his first attempt did not make it past the runway in Tacoma. He stated that Mr. Bromley then decided to take the plane to Japan and two years later successfully flew the plane to the Aleutian Islands. He stated that technically Mr. Bromley made it to one of the fifty states and the plane called the "Spirit of Tacoma" put the city of Tacoma on the map.

Council Member Miller stated that the braiding on the United States flag in the Council Chambers is in need of repair or replacement.

Council Member Miller requested information regarding the removal of the Schoenfelds' sign.

Public Works Director Bill Pugh responded to Council Member Miller's request stating that there are many signs that are not in compliance with the sign regulations in the downtown area. He stated that letters will be sent, within the next two weeks, requesting the owners of the buildings to comply with the sign regulations.

Mayor Ebersole stated that Ms. Barbara Clements, a reporter for The News Tribune, is moving on to a different assignment. He stated that Ms. Clements is a very fair and balanced reporter, who checks her sources. Mayor Ebersole then wished her well on her new assignment.

Council Member Silas also wished Ms. Clements good luck in her new position. Council Member Silas stated that she will miss Ms. Clements.

Council Member Silas moved to excuse Council Member McGavick from the January 6, 1998, City Council meeting and Council Member Phelps from tonight's meeting. Seconded by Deputy Mayor Crowley. Voice vote was taken and carried. The motion was declared adopted.

Mayor Ebersole thanked the City of Tacoma employees who drove the sanding trucks and those employees who stayed up all night responding to the snow storm. He stated that they did an excellent job in keeping the streets safe.
