Council Member Nielsen moved to excuse Council Member Silas from last week's Council Meeting. Seconded by Council Member Miller. Voice vote was taken and carried. The motion was declared adopted.

Deputy Mayor Mykland moved to cancel the regular City Council Meetings of December 21 and December 28, 1993. Seconded by Council Member Miller. Voice vote was taken and carried. The motion was declared adopted.

Council Member Silas reported on the opening of the UTRA Center. She then read a statement from Stacy Jones of Bryant Elementary School regarding what she wanted her ideal neighborhood to be.

Council Member McElliott thanked Council Member Silas for bringing this to the Council's attention.

Council Member Miller stated that last week Council Member Silas was ill which was the reason for excusing her absence from last week's meeting. He then encouraged all persons who had not done so to vote today.

Council Member Baarsma stated that Council received a memo from Kyle Crews dealing with senior citizen waivers of L.I.D. assessments. He requested that staff provide Council with information on the number of individuals who qualify under the program now, what the costs have been, what the projected costs if the program was expanded, and what the sources of funding might be.

Council Member Moss asked the City Manager for a report on what activities a "bed and breakfast" establishment may do beyond simply providing a bed and breakfast.

Council Member McElliott stated that the Planning Commission was still working on changes on this proposed ordinance.

Deputy Mayor Mykland stated he received a letter from the law firm of Small, Snell and Weiss stating they were moving out of the community due to gang-related problems. He stated that the City needed to deal with this matter.

Council Member Silas stated there was a meeting scheduled with business people and City staff next week on this matter.
