Odd Lund, Personnel Director, advised that this was a housekeeping Ordinance. All items have been negotiated.

Ordinance No. 20906 Vacating "T" Street between 59th Street and the alley to the south in the vicinity of Pipeline Road. (Roy J. Moore)

Bob Backstein, Hearings Examiner, advised that for final reading he would be bringing in a corrected ordinance to include a perpetual casement in favor of the City for repair and maintenance of water mains.

Ordinance No. 20907

Amending Chapter 13.06 of the Official Code to reclassify the west side of State between South 23rd and a point 290 feet north of South 25th Street from an "R-2" to a "PDB" District. (Tribune Publishing Company)

Mr. Backstein reviewed the area of the requested reclassification. He recommended a change in one of the conditions be placed on the reclassification and he referred to item d under section six of the conditions and asked that it be changed to read as follows: "The applicant shall enter into an agreement with the City of Tacoma, which agreement shall hold harmless the City of Tacoma from any liability it may incur as a result of any claims for damages which may arise as a result of the reclassification. This agreement may be waived in the event the applicant secures title to said property."

Mr. Schroeder moved to amend item d as stated by Mr. Backstein. Seconded by Mr. Nielsen. Voice vote was taken and carried.
