Amending Chapter 12.10 of the Official Code by repealing Sections 12.10.400 and 12.10.401 and reenacting Section 12.10.400 to authorize the Director of Public Utilities to enter into water service contracts for periods up to twenty years where service conditions are extraordinary.

Ordinance No. 23775

Approving and confirming the assessment roll for L.I.D. No. 3879 for the construction of sanitary sewers in the south side of South 61st Street from 75 feet east of Sheridan Avenue east 285 feet more or less (to "M" Street projected) then north 186 feet along the east side of Alling Park to the alley between South 60th and South 61st Streets.

Amending Chapter 13.06 of the Official Code to reclassify the property located at the northerly side of North 26th Street between Narrows Drive and Vassault Street from an "R-1" One-Family Dwelling District to an "R-3" Two-Family Dwelling District to allow for the construction of a duplex. (Towne Collins; File No. 120.1189)

Mayor Sutherland moved to concur in the Findings, Conclusions and Recommendations of the Hearings Examiner. Seconded by Council Member Nielsen. Voice vote was taken and carried. The motion was declared adopted.

### Ordinance No. 23778

Amending Chapter 13.06 of the Official Code to reclassify the property located on both sides of Ruston Way between the lown of Ruston and a line approximately 520 feet northwesterly of North 49th Street from an "M-3" Heavy Industrial District to an "S-6" Ruston Way Shoreline District to comply with the West End Plan. (City of Tacoma; File No. 120.1176)

Mayor Sutherland moved to concur in the Findings, Conclusions and Recommendations of the Hearings Examiner. Seconded by Council Member Mykland. Voice vote was taken and carried. The motion was declared adopted.

## Ordinance No. 23779

Appropriating \$15,277.75 from the General Fund for the Multicare Medical Center for the completion of a child abuse prevention project and for the emergency voucher program for temporary housing for the homeless, and declaring an emergency making necessary the passage of this ordinance.

Ordinance No. 23780

Authorizing an amendment to the contract with the Pierce County Area Agency on Aging to accept \$2,500.00 from Pierce County and depositing and appropriating said sum from the Miscellaneous Grants Summary Fund to provide reimbursement of case management assessment services regarding mental health clients served by the Comprehensive Mental Health Center.

Authorizing the execution of a Memorandum of Understanding with the Tacoma Public Library relative to the use of fire station property for purposes of constructing new additions to the library in exchange for parking spaces for the fire station on library property.

Council Member Hyde moved that the Resolution be adopted. Seconded by Deputy Mayor Rasmussen. Voice vote was taken and carried. The Resolution was declared adopted.

Authorizing the execution of an agreement with Harper, McLean and Company in the amount of \$17,000.00 to provide financial advisory assistance for the refunding of outstanding sewer utility revenue bonds.

Council Member Hyde moved that the Resolution be adopted. Seconded by Deputy Mayor Rasmussen. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 29468

Authorizing the retention of the law firm of Preston, Thorgrimson, Ellis & Holman as bond counsel for services relative to the sale and issuance of the City's sewer revenue bonds.
