Council Member Phelps discussed the proposed development of the Tacoma Dome parking lot by Cosmos International. He asked the City Manager to bring forward a Resolution rescinding the original Resolution with Cosmos International Corporation for the development of a portion of the Tacoma Dome parking lot. He stated that the Resolution should also include the initiation of a Request for Proposal to find the appropriate development for the Tacoma Dome parking lot.

Council Member Moss thanked Council Member Phelps for his time and commitment to the project and offered her support.

Council Member Miller praised the leadership of Council Member Phelps regarding the revitalization of the Dome area. He gave his support regarding the RFP process.

Deputy Mayor McGavick stated the Cosmos project has always been a Council driven initiative. She stated she would support the RFP process and thanked Council Member Phelps for his leadership efforts.

Council Member Talbert stated he supported Council Member Phelps in the RFP process and appreciated the opportunity to study a very complex issue. He stated the Dome area is the gateway to the community he represents.

Council Member Ladenburg commended Council Member Phelps for his hard work and commitment and stated she would support his proposed Resolution.

Council Member Evans stated that although he had not been in favor of the Cosmos proposal, he admired Council Member Phelps' dedication.

Mayor Baarsma expressed his appreciation to Council Member Phelps for all his efforts. He also stated this would enable the proposed agreement with the LeMay Car Museum to move forward.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Deputy Mayor McGavick stated she had represented the Mayor at the Regional Baptist Convention, held at the First Baptist Church in Tacoma, where she presented a proclamation. She reported her participation in the George, South Africa, teleconference and stated the Mayor of George hopes to come to Tacoma. She also stated she and Council Member Lonergan attended the dedication of the K.C. Family Foundation, where she presented a proclamation regarding foster care.

Council Member Moss stated she visited Franklin School this morning in relation to the two little girls which were accosted. She stated the principal seemed satisfied that the parents had been properly informed. She stated there was concern over the vegetation in the area and that she had stated the Council would take care of this as soon as possible.

Council Member Evans stated the downtown Farmers Market will open Thursday, June 6, 2002. He stated the Proctor Farmers Market opened last Saturday and the attendance had tripled.

Mayor Baarsma stated the Fife Jazz Band and Choir would be at the opening of the Farmers Market this Thursday, at 9 a.m., and that there would also be a cooking demonstration by the chef of the Primo Grill. He stated the Market is in its twelfth year and is the fifth largest market in the state. Mayor Baarsma stated the Tacoma Public Library will be having its annual Monster Book Sale on July 19-21, 2002, at Wilson High School. He stated Susan Odencrantz, Library Director, announced the library will be sponsoring its "Free to Read" summer reading program for youngsters, June 22 through August 10, 2002. He stated Council will celebrate and recognize the readers at the Point Defiance Zoo and Aquarium on Saturday, August 24, 2002.

Council Member Lonergan stated he represented the City last Thursday at the Department of Corrections' 2002 Annual Agency Awards Ceremony, for the West Central Region, at the Women's Correction Center in Purdy. He stated awards were presented and Judith Chelotti, a member of the North End Neighborhood Council, received an award for community service.
