Authorizing execution of a grant award agreement with the U.S. Department of Labor in the amount of \$25,000; creating a new fund to be designated as the Private Sector Opportunities Fund, and appropriating the sum of \$25,000, or so much thereof as may be necessary, from the Private Sector Opportunities Fund for the purpose of providing funding for training of low income citizens for private employment.

Decreasing the appropriation in the General Fund Legislative Department budget by \$30,286 for expenditures related to the position of Executive Assistant to the Mayor and Council and transferring the sum of \$30,286 to the Contingency Fund.

Mayor Parker referred to a proposal he had distributed to Council regarding the change he wished to make in the amount of savings which are listed in the proposal as \$7,710. The actual savings he said would be \$12,674. These savings referred to would be in the employment of an Office Services Supervisor. He also indicated the individual filling the position may be called upon to fill in for a Council member or himself at meetings which must be attended.

Referring to the proposal, Councilman Schroeder suggested that after the words "and who also could represent me on the Council of some of the meetings we must attend" add the words "said individual to serve as observer only."

After further discussion, Councilwoman Bichsel moved that the Ordinance be continued for one week until all of the members of the Council would be present and further review of the proposal. Seconded by Councilman Nielsen.

Roll call vote was taken, resulting as follows:

Amending Chapter 13.06 of the Official Code relating to setback regulations for accessory buildings; "PRD" Planned Residential Development District use regulations for multiple-family dwellings; expiration periods for Special Use Permits and parking regulations for warehouse and industrical uses.

PUBLIC HEARINGS AND APPEALS:

a. This is the date set for hearing the appeal of Pierre C. Davis on the denial of a Burglar Alarm Mechanic's License Application.

Dick Newman, Tax & License Department Director, advised that the license was denied because the applicant Robert H. Davis did not meet the minimum age requirement of 18 as provided under Chapter 6.02 of the Official Code. Mr. Davis is 16 years old. City Council Minutes - Page 10 - February 6, 1979

Pierre C. Davis, President of Burglar & Fire Alarm Association of Washington, and father of Robert Davis, answered questions of Council members and informed them that his son holds a State Journeyman low-voltage Electrician's license, and is allowed to install burglar alarms in Seattle and other areas. He asked that the license be granted.

After discussion, Deputy Mayor Warnick asked that he be provided with a list indicating all the individual license holding positions the City has. Deputy Mayor Warnick moved that an ordinance be prepared requiring exhibition of a Journeyman's license before a mechanic's certificate be issued to anyone regardless of age. Seconded by Mayor Parker. Voice vote was taken and carried.

Mayor Parker moved that in the interim, all other criteria being met, that Robert H. Davis be granted a Burglar Alarm Mechanic's License. Seconded by Deputy Mayor Warnick. Voice vote was taken and carried.

COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Mayor Parker moved to recess into Executive Session for the purpose of receiving legal counsel. Seconded by Councilman Nielsen. Voice vote was taken and carried. Council recessed at 6:30 p.m. Council reconvened at 6:45 p.m.

Mayor Parker moved that the appropriate officer of the City of Tacoma be authorized and directed to settle Pierce County Cause #252218 on the understanding of terms contained in the memorandum from the City Attorney to the City Manager dated February 5, 1979. Seconded by Councilman Schroeder. Voice vote was taken and carried.

Councilman Schroeder commented on the appropriate gift, the Key to the City, which the Mayor presented to the Vice Premier of China recently when he visited Seattle.

Mayor Parker commented on the interesting weekend with the China Vice Premier and his delegation and the benefit it may bring by having the City represented at the various meetings and the luncheon.
