# REPORTS BY CITY MANAGER

Interim City Manager James Walton, stated that he was pleased to report that the Abandoned Vehicle Program is back in business. He stated that the savings have been



found in vacant positions to meet this high expectation from the City Council and the citizens of Tacoma.

Mr. Walton acknowledged that the actions of the City Council this evening led to his understanding as to why the City of Tacoma is being recognized by the Association of Washington Cities as a "Diversity Champion." He stated that this award will be presented at the annual conference on the 18<sup>th</sup> of June in Spokane, Washington.

Mr. Walton reminded the City Council of the invitation they had received to attend the Municipal League 2003 Distinguished Citizens of the Year Award Luncheon, where Deputy Mayor Bil Moss will receive an award.

Mr. Walton then requested an Executive Session to discuss potential litigation, the session not to exceed 30 minutes.

## COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Mayor Baarsma stated that he had attended a banquet and fundraising event last Saturday to promote Chinese Reconciliation project. He stated that the General Consul of the People's Republic of China, Ambassador Wong, had been present to lend his support and commitment to our Sister City in China as a participant in that project.

Council Member Ladenburg announced that next week's City Council meeting would be held at Bates Technical College, South Campus, Administration Building, 2201 South 78<sup>th</sup> Street, which is in Council District No. 5. She stated that a regular City Council meeting would be held beginning at 5:00 p.m. and would be immediately followed by the Town Hall meeting. Council Member Ladenburg stated that she will give a short presentation, followed by a Budget 101 presentation by Diane Supler, Director, Office of Management, Budget and Analysis.

Deputy Mayor Moss moved to excuse Council Member Phelps from the meeting. Seconded by Council Member McGavick. Voice vote was taken and carried. The motion was declared adopted.

Council Member Lonergan congratulated the North Slope Historic District for being placed on the National Register of Historic Places. Council Member Lonergan also stated that he had attended an event on Ruston Way and had presented a proclamation proclaiming "National Trail Day." He commented that the refurbished old Temple Baptist Church on St. Helens Street is now called the Metropolitan Apartments. Council Member Longeran also stated that he is pleased with the reinstatement of the Abandoned Vehicle program.

Council Member Ladenburg commented that the slide show at the American Travel Writer's Society reception included some phenomenal pictures of Tacoma.

Mayor Baarsma stated that he also had attended the reception for American Travel Writer's Society and that the Society was surprised and delighted at the progress the City of Tacoma has made in recent years.
