## **REPORTS BY CITY MANAGER**

Mr. Ray E. Corpuz Jr., City Manager, introduced Captain Ron Stephens, Fire Department Training Division, as the next Special Assistant in the City Manager's Office.

City Manager Corpuz requested a temporary six-month residency waiver for Ms. Tanya Harmon, Administrative Services Manager, in the Police Department; and a permanent residency waiver for Ms. Elaine Hopkins, Court Clerk, in the Tacoma Municipal Court.

Council Member Crowley moved to authorize the City Manager to grant a temporary six-month residency waiver for Ms. Tanya Harmon, to fill the position of Administrative Services Manager in the Police Department. Seconded by Council Member De Forrest. Voice vote was taken and carried. The motion was declared adopted.

Council Member Crowley moved to authorize the City Manager to grant a permanent residency waiver for Ms. Elaine Hopkins, Court Clerk I, in the Tacoma Municipal Court. Seconded by Council Member Baarsma.

Council Member De Forrest moved to amend the motion to a one-year residency waiver. Seconded by Council Member McGavick. Voice vote was taken and failed with

Council Members De Forrest, McGavick and Silas voting in favor of the motion. The motion was declared failed.

Mayor Ebersole stated that the City Council now has before them the motion to authorize the City Manager to grant a permanent residency waiver for Ms. Elaine Hopkins to fill the position of Court Clerk I, in the Tacoma Municipal Court.

Roll call vote was requested and taken, resulting as follows:

## **COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL**

Council Member Silas stated that she participated in the ribbon cutting ceremony of the new Rite Aid store, located on the corner of South 11<sup>th</sup> Street and Martin Luther King, Jr. Way. She stated that none of this could have happened without the support of the Hilltop residents and the Tacoma Police Department. She stated that the Rite Aid store is Hilltop's anchor to the revitalization of retail in the neighborhood. Council Member Silas stated that it is her understanding that the new Rite Aid store on South 11<sup>th</sup> Street and Martin Luther King, Jr. Way is the best one built in the state of Washington.

Council Member Miller moved to accept the settlement in the matter of <u>Orchard</u> <u>Reach Partnership v. City of Tacoma</u>, Pierce County Superior Court Cause No. 96208661-0, for the sum of \$75,000. Seconded by Council Member Crowley. Voice vote was taken and carried. The motion was declared adopted.

#### \*\*\*\*\*

Deputy Mayor Kirby stated that he and Council Member Baarsma attended a Library Board meeting last week, at which time there was a presentation made by the consultant who did the performance audit on the Library. He expressed his disappointment in the outcome of the audit and the issues the audit addressed. He stated that it was his opinion the performance audit should have addressed the labor/management issues that have been ongoing for years. He stated that, during the presentation of the performance audit at the Library Board meeting, citizens in the audience and members of Library Board made comments that led him to believe that at least one Library Board Member and two new Library Board Members were not interviewed for the audit. Deputy Mayor Kirby stated that he hopes the City Council supports the Library Board in rejecting the performance audit. Council Member Baarsma stated that the consultant who performed the performance audit recommended a number of incremental changes involving staff scheduling and some minor organizational adjustments. He stated that although the audit did not address the labor/management issue, it does address the issue of expenditures, particularly in training, processing grievances, and teaching managers how to conduct performance appraisals. He stated that the audit report indicates that only a third of the training budget is devoted to training librarians to deal with new technology. He stated that the audit report recommended that the library staff meet with the budget staff and scrutinize the numbers prior to the budget coming before the City Council for consideration and approval. Council Member Baarsma stated that although there had been ongoing discussions with the management team at the library as the performance audit unfolded, there were no discussions with the employees, nor the two new board members that were brought into the process. He stated that the interim library director is very much aware of the flaws and problems and has expressed some concerns with the report. Council Member Baarsma stated that the consultant took the top 20 library systems in the United States, with the service area of 150,000 to 250,000, and looked at the amount of tax dollars per capita contributed by these systems. He stated that the average was \$33.97 per capita. He stated that the City of Tacoma is \$47.19 per capita. He also stated that the audit report showed that the average number of citizens having library cards per capita is 67 percent and in the City of Tacoma it is 92 percent. He stated that the City of Tacoma is also above average in materials at the Library. He stated that the City of Tacoma has a lot to be proud of in terms of our library system, but the performance audit needs to be returned to the sender with more work needed.
