# RESOLUTIONS

### Resolution No. 36586

Setting Tuesday, August 9, 2005, at approximately 5:30 p.m. as the date for a hearing by the City Council regarding the proposed transfer of property located at Lake Kapowsin, Pierce County, and a portion of the land in the upper Green River Watershed near Friday Creek, King County, to the Muckleshoot Indian Tribe.

Vacating a portion of South Asotin Street north of Center Street and south of South 28<sup>th</sup> Street for the construction of a storage and repair building. (Network Services d.b.a. Network Tacoma; File No. 124.1244)

Vacating a portion of the Commerce Street right-of-way between South C Street and Pacific Avenue and abutting South 28<sup>th</sup> and South 29<sup>th</sup> Streets for the construction of a mixed-use, commercial/residential development. (Seven Stones, LLC and William Baker; File No. 124.1245)

Seconded by Council Member Talbert. Voice vote was taken and carried. The motion was declared adopted.

City Manager Eric Anderson stated Fire Chief Eileen Lewis will go on leave August 1<sup>st</sup> and retire thereafter. He stated Mr. Ron Stephens will serve as Interim Fire Chief.

# COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Lonergan commented on the retirement of Fire Chief Eileen Lewis. He also stated the Joint Municipal Action Committee (JMAC) took a real interest when the City of Federal Way showed interest in the Browns Point area. He stated JMAC sent a letter to the Pierce County Regional Council (PCRC) opposing the idea of opening up the Browns Point/Dash Point area as an Urban Service area for Federal Way. He stated it has been a part of Tacoma's urban growth area in Pierce County. He indicated that at the recent PCRC meeting, they reviewed nine different proposals to modify the Pierce County's Comprehensive Plan relating to various urban growth areas. He stated the PCRC voted against the Federal Way proposal. He mentioned the upcoming Ethnic Fest event at Wright Park and Air Expo at McChord Air Force Base this weekend, which will feature the United States Air Force Thunderbirds.

Mayor Baarsma mentioned the upcoming Fern Hill Days event on Sunday. He also stated the United States Association of Ecological Economists convention was held in

Tacoma. He then congratulated Fire Chief Eileen Lewis, first female firefighter and Fire Chief on her retirement.

Council Member Evans also mentioned the upcoming Ethnic Fest at Wrights Park.
