Ordinance No. 25497

Amending Chapter 13.06 of the Official Code to reclassify the property located between South 61st and South 64th Streets, extended, approximately 200 feet west of Sheridan Avenue, from a "R-2" One-Family Dwelling District to a "R-2PRD" Planned Residential Development District for the construction of 18 attached single-family dwellings and 5 detached single-family dwellings on separate lots. (Jeff Christensen; File No. 120.1374)

Mayor Moss moved to concur in the Findings, Conclusions and Recommendations of the Hearing Examiner. Seconded by Council Member Evans. Voice vote was taken and carried. The motion was declared adopted.

The Ordinance was set over for final reading to a date to be determined.

Ordinance No. 25498

Amending Section 8.01.010 of the Official Code for a mandatory jail term upon a third domestic violence offense within a two year period.

Council Member De Forrest moved that the Resolution be adopted. Seconded by Council Member Crowley. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 32606

Authorizing the submittal of a grant application to the State of Washington Interagency Committee for Outdoor Recreation in the amount of \$210,000 for facilitating the construction of a boat launch facility on the Thea Foss Waterway.

Council Member Crowley moved that the Resolution be adopted. Seconded by Council Member McGavick. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 32607

Authorizing the Rainier Cable Commission to investigate and evaluate proposals on basic tier cable rates and increase refunds and charges for associated equipment, installation and services.

Council Member Evans moved that the Resolution be adopted. Seconded by Council Member Crowley. Voice vote was taken and carried. The Resolution was declared adopted.

UNFINISHED BUSINESS:

None.

REPORTS BY CITY MANAGER:

Ray E. Corpuz, Jr., City Manager, requested Council Members to pick up copies of the fiscal and financial policies and the Strategic Plan revisions, after the Council meeting, for the budget workshop on Thursday, May 12.

Mr. Corpuz encouraged everyone to participate in Carless Commute Week, which will begin next week for two weeks.

Mr. Corpuz announced that the month of May is Asian Pacific Heritage month and encouraged Council to partake in the activities planned.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Mayor Moss moved to excuse the absence of Council Member Silas. Seconded by Council Member Evans. Voice vote was taken and carried. The motion was declared adopted.

Mayor Moss moved to approve Council Member Miller's trip to Germany. Seconded by Council Member Crowley. Voice vote was taken and carried. The motion was declared adopted. Mr. Corpuz indicated that Council Member Miller will be representing the United States along with 17 other representatives to share their experiences in trying to reclaim industrial waterfront land.

Council Member Baarsma regretfully announced that the Seattle Supersonics are now history until next year; however, welcomed them to Tacoma next year.

Council Member Baarsma expressed his gratitude to Charlie Hansen, Fire Prevention Bureau, for the information on the number of fireworks related injuries. Council Member Baarsma indicated that the editorial in today's *Morning News Tribune* suggested that the ban of fireworks continue. Council Member Baarsma stated that there was an average of 23 injuries until the ban took place; and when the ban took place, the injuries totaled 5. Council Member Baarsma indicated that the *Morning News Tribune* promotes the sale of illegal fireworks through promotional ads and

requested that a letter be sent to the Editor of the *Morning News Tribune* suggesting that the *Tribune* not accept advertising that promotes the sale of illegal fireworks.

Council Member Kirby reported that recently his wife and children spent some time on the waterfront and appreciated the work of the Police Department patrolling Ruston Way.

Council Member Evans emphasized that the City should not incur further liability to encourage the use of fireworks.

Council Member De Forrest indicated he had talked to Fire Chief Moore about Charlie Hansen's memo on fireworks. He indicated that a more scientific survey will be put together so that the figures will mean something other than a type of emotional appeal. Council Member De Forrest thanked Peter Luttropp, Finance Director, for the information on bonds, and thanked Valerie Sivinski, Historic Preservation Officer, for accepting an award on the Union Station project in Olympia.

Council Member Miller reported that earlier Mr. Daniel Peluso spoke to the Council and asked what he could do to involve children in activities. Council Member Miller indicated that Mr. Peluso is putting together a proposal to have two boats take low-income children fishing out of Westport. Council Member Miller indicated that Mr. Peluso is seeking mentors to participate in this activity and encouraged a Council representative to participate. The event is scheduled for June 8.

Council Member McGavick reported that one lesson she has learned while being on this Council is to never be listed as an undecided vote. Council Member McGavick indicated that she received numerous calls to support the ban on fireworks. Council Member McGavick stated that she will be absent at next week's Council meeting and respectfully requested that she be excused.

Mayor Moss indicated that he was pleased to witness a man who had been imprisoned for 27 years be elected as President of South Africa.

Council Member Miller moved that a letter of congratulations from the Council be sent to President Nelson Mandela. Seconded by Council Member Baarsma. Voice vote was taken and carried. The motion was declared adopted.

Mayor Moss moved to recess to Executive Session not to exceed 45 minutes to discuss pending and potential litigation. Seconded by Council Member Miller. Voice vote was taken and carried. Council recessed to Executive Session at 9:15 p.m. and reconvened at 9:45 p.m.

Mayor Moss announced that a Special Meeting of the Council will be held on Thursday, May 12, 1994 at 5:00 p.m. in the Council Chambers.

On proper motion, the meeting was adjourned at 9:45 p.m.
