Adopting the General Government Fee Schedule for special and miscellaneous services to allow for full cost recovery of services.

Resolution No. 36385

Accepting \$1,609,791 from the United States Department of Justice, Office of Community Oriented Policing Services; and authorizing the execution of an interlocal agreement with the City of DuPont, City of Lakewood, City of Puyallup, Pierce County Fire District, and Tacoma School District No. 10, for regional interoperability communications.

Deputy Mayor Evans moved that the Resolution be adopted. Seconded by Mayor Baarsma. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36386

Authorizing the execution of a Construction and Maintenance Agreement with The Burlington Northern and Santa Fe Railway Company to establish the terms and conditions for the performance of work set forth as part of the D Street Overpass Project.

Deputy Mayor Evans moved that the Resolution be adopted. Seconded by Council Member Anderson. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36387

Authorizing the execution of a purchase and sale agreement, a quitclaim deed, and a temporary construction easement with The Burlington Northern and Santa Fe Railway
