Mr. Warnick excused himself from participating in consideration of the Ordinance due to a possible conflict with the appearance of fairness doctrine. Mr. Warnick left the Council Chambers.

Speaking against the Ordinance was Jim Barglet, property owner, representing seven property owners on the west side of Shorecliff Drive. He suggested that the sewer be run along the back lot line in Shorecliff Terrace along lots 10 through 15 rather than along Shorecliff Drive. He claimed this would be cheaper and more efficient.

Ron Button, Director of Public Works, advised, that recorded opposition to the L.1.D. was 33% of the property owners.

Mr. Sonntag moved to delete from the Ordinance that portion on Shorecliff Drive, namely lots 4 through 6. The motion failed for lack of a second.
