FINAL READING OF ORDINANCES:

Ordinance No. 25792 (Continued from the meeting of November 28, 1995)

Establishing a "B" Business District interim zoning classification for certain properties within the City of Tacoma to allow for expansion of the Pierce County Corrections and Detention Center and declaring an emergency, making necessary the immediate passage of this ordinance.

Council Member De Forrest moved to suspend the rules to consider Substitute Ordinance No. 25792. Seconded by Deputy Mayor Evans.

Council Member Miller moved to suspend the rules to consider Resolution No. 33219. Seconded by Council Member Kirby.

Council Member De Forrest moved to postpone consideration of Substitute Ordinance No. 25792 until after consideration of Resolution No. 33219. Voice vote was taken and carried. The motion was declared adopted.

Council Member Miller moved to suspend the rules to consider Resolution No. 33219. Seconded by Council Member Kirby. Voice vote was taken and carried. The motion was declared adopted.

Resolution No. 33219

Authorizing the execution of an interlocal agreement with Pierce County regarding the site of a temporary jail facility to be located in the County-City Building parking lot and



further expressing the support of Pierce County's effort to secure financing for a permanent jail facility.

Council Member Miller moved to adopt Resolution No. 33219. Seconded by Deputy Mayor Evans.

Council Member Miller moved to amend the interlocal agreement being considered with Resolution No. 33219 by the editing of paragraph 3.1 as follows:

"3.1 The County will construct a permanent jail facility which will be operational no later than July 1, 2001. Financing will be determined prior to construction. In consideration thereof, the City will zone that the portion of the County-City Building site legally described on Exhibit "A" attached hereto and fully incorporated herein by reference, upon which such temporary jail facility may be constructed as B-Business, pursuant to Section 3.7 below."

and to include Exhibit "A", as presented by Council Member Miller, which is the legal description of the site on which the temporary jail facility will be located. Seconded by Council Member Silas. Voice vote was taken and carried. The motion was declared adopted.

Council Member Miller moved to amend the interlocal agreement by adding paragraph 3.13 as follows:

"3.13 The City may, at its discretion, bring a lawsuit to compel specific performance of the terms of this agreement. In addition to all other remedies available to the City by law, the City reserves the right to revoke the rezoning of the site and require removal of the temporary jail within 180 days, should the County fail to comply with any of the terms and conditions of this agreement."

Seconded by Council Member De Forrest.

Robin Jenkinson, City Attorney, proposed additional language to Council Member Miller's amendment as follows:

"and any cost and expense incurred by the City for such removal shall be reimbursed by the County."

Council Member Miller and Council Member De Forrest concurred with the proposed addition to the amendment. Voice vote was taken and carried. The motion was declared adopted.

Council Member Silas moved to amend paragraphs 3.9 through 3.12 of the interlocal agreement to read as follows:

"3.9 The County agrees to immediately negotiate with a Citizens Advisory Committee on Corrections to look for creative alternatives to incarceration for certain misdemeanor offenses, and to expand and support the current effective correction programs and services that are working. The committee should consist of at least seven, but no more than eleven, residents from the Third and Second Councilmanic Districts of the City of Tacoma as recommended by the Tacoma City Council and one resident from each of the Pierce County Councilmanic Districts. It is further agreed that the County will provide the necessary staff support and other resources as needed to facilitate the work of the Advisory Committee.

The County shall, in an amount of not less than \$30,000, fund a study by a qualified consultant with expertise in viable alternative methods to incarceration with such consultant to be jointly selected by the City and County. In addition to the study, the consultant, at the expense of the County, will advise and discuss, with the Citizens Advisory Committee on Corrections, viable alternative methods to incarceration.

3.10 The County agrees to meet its own minimum Minority and Women's Business Enterprise goals of 14% for Minority Business Enterprises and 8% for Women's Business Enterprises on the permanent jail facility constructed by the County.

3.11 The County agrees to participate in the local employment program adopted by the City of Tacoma to ensure that qualified and available residents from the City of Tacoma's Empowerment/Enterprise Zones are hired and receive apprenticeship training as a part of any and all constructed correction facilities authorized by the County.

To facilitate the participation for the City of Tacoma's Zone residents in Joint Apprenticeship and Training Council-approved apprenticeship programs offered by Bates Technical College, or other approved colleges, the County agrees to pursue funding for an apprenticeship scholarship program for those residents who qualify for education assistance. The Citizen Advisory Committee on Corrections will provide advice, assistance, and oversight for the scholarship program.

3.12 The County agrees to study, analyze and mitigate adverse impacts to the neighborhood which may occur as the result of the placement of the

temporary jail facility on this site. Special emphasis shall be placed on continuing and enhancing such programs as El Cid, electronic home monitoring, work crews and drug rehabilitation programs. The cost of these enhancements will not exceed \$100,000."

Seconded by Mayor Moss.

Council Member McGavick moved to amend paragraph 3.10 of the interlocal agreement by adding the temporary jail facility to the language as follows:

"...the permanent and temporary jail facilityies constructed by the County."

Accepted by Council Member Silas. Voice vote was taken and failed. The motion was declared failed.

Council Member Crowley moved a friendly amendment to paragraph 3.12 of the interlocal agreement by adding language to the last line as follows:

"The cost of these enhancements will not exceed \$100,000 by July 1, 2001."

Council Member Silas and Mayor Moss concurred with Council Member Crowley's friendly amendment.

-- Public Records and Open Meetings. Council Member De Forrest strongly opposes the City lobbying to make it more difficult for citizens to access their government. He strongly objects to the language that the City would want to change the law so that the City would not be required to provide information to the public if the information is stored in such a manner that collecting it would significantly disrupt the operations of the City or any department. Council Member De Forrest said he is strongly in favor of the City recording Executive Sessions.

-- Ominous Fire Arms Legislation. Council Member De Forrest opposes the City lobbying to change the state law to allow for local option on gun control or gun laws.
