REPORTS BY CITY MANAGER

City Manager Ray E. Corpuz, Jr. reminded the City Council Members that Monday, January 20, 1997 is a holiday celebrating the birthday of Dr. Martin Luther King, Jr. Mr. Corpuz stated that there would be a celebration at the Tacoma Dome Exhibition Hall starting at 10:00 a.m., with a free continental breakfast to the public. Mr. Corpuz then stated that the actual program starts at 11:00 a.m. and the focus of that program is "The Power of the Dream." He stated that the Washington State History Museum will also be hosting a special reception in recognition of the Tuskegee Airmen.

City Manager Ray E. Corpuz, Jr. then requested an Executive Session to discuss potential litigation and labor negotiations, not to exceed 60 minutes.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Miller moved to excuse Council Member Silas from the meeting. Seconded by Council Member Evans. Voice vote was taken and carried. The motion was declared adopted.

Mayor Ebersole thanked Pierce County Prosecutor John Ladenburg for enduring the three-hour meeting.

Council Member De Forrest stated he appreciated that there is now an agreement with TVW to televise some of the legislative action. He stated he was still not happy with the hours proposed and hoped that crucial issues dealing with the City of Tacoma would be broadcast live. Mr. De Forrest requested that Mr. Lewis notify the City Clerk when there are hearings on issues for which the City of Tacoma is lobbying, or that deal with the City of Tacoma, so that TV Tacoma could possibly pre-empt other programs.

Mayor Ebersole stated that he was not sure how much latitude the City of Tacoma had in what programming they receive, but he commended the City Manager and his staff for working this out so we can see the deliberations in Olympia. Council Member Miller stated that last Wednesday was the official signing ceremony for the ASARCO Agreement, which took place at the Tacoma Yacht Club on the site of the ASARCO redevelopment area. He stated it was a tremendous event, which was attended by a number of people, and marked the initiation of the countdown to the year 2003, when it is anticipated the site will be completely cleaned up and available for development. He stated that it was a momentous occasion and one of the greatest days in his life. He thanked City Council Members for their trust in him and thanked City Manager Corpuz and staff, who participated in the negotiations and made it a success.

Council Member De Forrest thanked Council Member Miller for his work on the ASARCO project.

Deputy Mayor Baarsma thanked City Attorney Robin Jenkinson for providing a copy of a memo that she sent to City Manager Corpuz concerning potential participation on the part of City Council Members in the City's retirement system. He stated that he had misspoken last week in implying that they have a defined contribution plan when, in fact, the City Council Members would participate in the City's defined benefit plan, which requires both employee and employer contributions.

Mayor Ebersole stated his condolences from the City Council to the family of Firefighter Jimmy Cason.

Council Member Miller moved to recess to Executive Session to discuss potential litigation and labor negotiations, not to exceed 60 minutes. Seconded by Council Member Crowley.

Council Member De Forrest asked about the topic of discussion that would take place in the Executive Session.

City Attorney Robin Jenkinson stated that there is a section in the Open Public Meetings Act that creates an exception under the Executive Session portion. Ms. Jenkinson then read the exception "To discuss with legal counsel representing the agency matters relating to agency enforcement actions, or litigation or potential litigation to which the agency, the governing body, or a member acting in an official capacity is, or is likely to become, a party, when public knowledge regarding the discussion is likely to result in an adverse legal or financial consequence to the agency." She stated she was quoting from RCW 42.30.110(1i).

Council Member De Forrest than asked if the discussion in Executive Session would be about the City of Tacoma being sued or if the City of Tacoma was planning on suing somebody?

City Attorney Robin Jenkinson stated the discussion would be about entering litigation, actually initiating an action against another party.

Council Member De Forrest asked if this was in the city limits of Tacoma.

City Attorney Robin Jenkinson responded no.

Council Member De Forrest stated that he had concerns regarding the City of Tacoma joining some other action that was outside the city limits. He stated that since the City of Tacoma had not been sued and unless the City of Tacoma was going to sue some party within the city limits with what he felt was a violation, he did not think the Executive Session was proper.

Robin Jenkinson then stated that the exception is an action to which the City may become a party, so it would not have the geographical constraints.

Council Member De Forrest stated that he may remove himself from the Executive Session at that point.

The City Council convened to Executive Session at 8:17 p.m.

At 9:17 p.m. Mayor Ebersole extended Executive Session for an additional 35 minutes. At 9:48 p.m. the City Council reconvened and adjourned.

On proper motion, the meeting was adjourned at 9:48 p.m.
