Resolution No. 25396 (Continued from the meeting of November 14)

Authorizing execution of an agreement with the Growth Policy Association of Pierce County for certain services relating to land use planning, utility and municipal services and recommendations relating to joint governmental activities by and between the City, the County of Pierce, and the Port of Tacoma.

Councilman Hudson moved to consider Substitute Resolution No. 25396. Seconded by Mayor Parker. Voice vote was taken and carried.

Councilman Schroeder moved that the Resolution be adopted. Seconded by Councilman Evans. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 25400

Authorizing execution of a joint Tacoma-Seattle application for funding under the Federal Air Quality Technical Assistance program.

Councilwoman Bichsel moved that the Resolution be adopted. Seconded by Councilman Hudson. Voice vote was taken and carried. The Resolution was declared adopted.

COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Mayor Parker moved that the City of Tacoma through its Mayor and Council sponsor an open house and Christmas reception Thursday, December 21, 1978, from 3:00 to 8:00 p.m. in the Council offices in the County-City Building and further that the proper officers of the City be, and they are authorized to extend certain written invitations to citizens of the City thereof. Seconded by Councilman Strege. Roll call vote was taken, resulting in Ayes: 4 - Evans, Kirby, Strege and Mayor Parker. Nays: 5 - Bichsel, Hudson, Nielsen, Schroeder and Warnick. The motion was declared failed.

Mayor Parker announced that on Thursday, Thanksgiving Day, there will be three sittings of Thanksgiving dinner at the Bicentennial Pavilion, at 12:00 noon, 3:00 p.m. and 6:00 p.m. He advised that 60 businessmen are sponsoring a table at \$100 a piece. Tickets are being distributed through the Department of Human Development. He urged Council members to attend.

CITIZEN'S REQUEST TO BE HEARD:

Ellida H. Kirk, requesting to speak on behalf of the Wapato Neighborhood Coalition.

Ellida Kirk, speaking on behalf of the Wapato Neighborhood Coalition, asked that Council reconsider Resolution No. 25372 which had been adopted October 31, 1978, reconsidered and failed on November 8, 1978. The Resolution authorizing a feasibility study of acquiring approximately 11 acres of property in the vicinity of Wapato Park for open space.

Mayor Parker moved to suspend the rules to allow a representative of the Old City Hall to extend an invitation. Seconded by Councilman Schroeder. Voice vote was taken and carried.

Laura Johnson, representing the Old City Hall, invited Council members and citizens to an open house on December 1, 1978 from 10:00 a.m. to 9:00 p.m.
